District Engineers Work with Rivers Instead of Fighting Them

You can't bully a river. This is a lesson I learned in the coldest part of February when I attended a week-long river course in Asheville, NC taught by Dave Rosgen, a world-renowned expert on river flow. The District has designed fish habitat using Rosgen structures in co-operation with the Natural Resources Conservation Service (NRCS), Partners for Trout, and the Foothills Resource Conservation and Development (RC&D) Council. We have enhanced trout habitat in several streams and rivers in the northern part of Greenville County. This partnership has also used Rosgen structures to slow water naturally in urban settings in the County.

The course taught fundamentals of river structure and described aquatic characteristics and stream restoration during three days in the classroom. The purpose of the course was to show how to work with the river instead of against it. When we try to bully a river into place, in many instances it will fight back. Over the years, the same "fix" will have to be implemented again and again, wasting millions of dollars.

In addition, the course included two days of field work. The syllabus warned that the field work would be undertaken no matter what the weather was, and they weren't kidding. I found myself up to my waist in a cold mountain stream in Pisgah National Forest, with four inches of snow on the ground, and a steady 37 degree rain the whole day. Having appropriate clothing and experiencing the thrill of learning something new made the day a highlight of the course, despite the weather.

The class gave me a new respect for and love of rivers. I came away with a strong grounding in the basics of rivers and an introduction to the design of structures that work with instead of fight the river. I'm looking forward to implementing my new knowledge to save money while enhancing aesthetics, improving fish habitat, and guiding the river naturally.

Here's a quote from Hal Boyle that sums up what I learned at the Rosgen course. "What makes a river so restful to people is that it doesn't have any doubt -- it is sure to get where it is going, and doesn't want to go anywhere else."

Greenville County Soil & Water Conservation District has already been working on this, meeting with each County Council member to express appreciation for their support and to inform them of the important work we do throughout the county.

This Fall, the Greenville Conservation District selected seven lucky students to participate in the Carolina Coastal Adventure (CCA).

The Berkeley County Soil & Water Conservation District hosts CCA at the Santee Cooper Somerset Facility in Moncks Corner each year. Students from all of the 46 conservation districts across South Carolina attended. The group from Greenville County was the largest delegation from a single county.

The ninth and tenth graders were treated to a weekend on the coast, where they learned about marine wildlife, coastal environments, and water quality issues.

CCA also featured interactive educational experiences at Cypress Gardens and leisurely afternoon canoeing in Old Santee Canal Park. Students particularly enjoyed castnet fishing and trawling the ocean aboard the Department of Natural Resources' Discovery vessel. A bonfire on the banks of Lake Moultrie capped off the weekend as our delegates said goodbye to new friends.

Greenville County also sent two counselors from the Upstate, DNR's Ken Forrester, an experienced CCA'er, and the District's JC Ward, a first-time counselor.

School Programs

Greenville County Soil & Water Conservation District reached a record number of students in Greenville County during the 2009-2010 school year! The School District allows staff from GCSWCD to present interactive, educational experiences to children of all ages as part of their cooperative agreement with Greenville County.

Historically, the GCSWCD has offered a soils class and a water quality class for area schools. In 2009, JC Ward, District Education Program Manager, developed new classes for each grade, which meet the South Carolina Standards for Science. This year, 62 new classes were led by JC, which amounts to 1,860 students reached by the GCSWCD's message of natural resource conservation. The new classes have led to some interesting educational opportunities, such as participation in Science Day and features on school internet blogs.


