Greenville County Government

Greenville County Council was created in 1967 by the South Carolina General Assembly. In 1973, a County Executive was appointed to oversee the daily operation of delivering county government services. In 1976, under Home Rule legislation, Greenville County adopted the council/administrator form of government. The County Council is the legislative, policy-making body for county government. The twelve County Council members elected from single-member districts serve four-year staggered terms. Greenville County provides a full range of government services, including law enforcement, judicial system, health services, social services, emergency medical transport, infrastructure construction maintenance and comprehensive planning.

> The **unemployment rate** for Greenville County remained lower than that of the state of South Carolina for 2013 with the County's unemployment rate averaging 7.1% and the state's unemployment rate averaging 8.1%. These rates have decreased from 2012 when the unemployment rate for Greenville County was 8.2% and the unemployment rate for the state of South Carolina was 9.4%.

Encouraged by abundant streams and rivers, textile manufacturers began operating in the Upstate in the 1820's. Over the past thirty years, Greenville County has transformed from the textile capital of the world to a headquarters, manufacturing and warehousing center.

Greenville is known for its high-technology manufacturing, with the engineering industry having a major presence in the area. Considered to be the "economic engine of South Carolina," Greenville is the largest county in the state. Situated in the northwestern corner, Greenville County is part of one of the nation's fastest growing areas, "The I-85 Corridor," and offers the perfect combination of industry, work force and culture.



The Greenville County DNA lab now submits DNA profiles to the FBI's Combined DNA Index System (CODIS), a national database developed from crime scenes all across the country. CODIS is a valuable tool allowing for faster identification of suspects. This saves time and money by shortening the length of investigations.

Summary of Financial Information

The County's Comprehensive Annual Financial Report (CAFR) is presented in accordance with generally accepted accounting principles (GAAP). The presentation of this report differs from GAAP because the data presented is only for the primary government which includes all Greenville County governmental functions. The Greenville County Redevelopment Authority and the Greenville County Library System are excluded.

Governmental activities of Greenville County include the general government, public safety, highways and streets, economic development, judicial services, health and welfare, and culture and recreation. Governmental activities generally are financed through taxes and intergovernmental revenues.

Business-type activities include solid waste disposal, storm water quality and control, and the parking facility. These activities are intended to recover all or a significant portion of their costs through user fees and charges.

Balance Sheet

More formally referred to as the Statement of Net Position (assets minus liabilities), the balance sheet reflects Greenville County's strong financial position.

Explanations *of* Major Fluctuations:

The increase in net position of governmental activities is primarily due to long-term debt retirements. The increase in business-type activities is mostly due to additional landfill revenue coupled with a decrease in expenses, resulting in a \$3,677,286 increase in cash year over year.



Greenville County developed a new approach for dealing with e-waste. By segregating this waste and searching for vendors willing to pay for the value rich items, the County saved \$61,000 during fiscal year 2013.

Income Statement

The County's income statement, referred to as the Statement of Activities, reports all financial activity during the fiscal year.

Explanations of Major Fluctuations:


The increase in net position of governmental activities is mostly due to a \$7 million increase in property tax revenues, as well as, an increase in the state allocation. In the business-type activities there were increases in property taxes and charges for services in the Solid Waste fund. Expenses were also lower in this fund in 2013 compared to 2012.




Greenville County's DNA lab received national accreditation. It is one of only three such accredited labs in South Carolina. This accreditation benefits the County by providing a much quicker turnaround of evidence and benefits the state by alleviating pressure on the State Law Enforcement Division lab in Columbia.


Revenue Sources – Governmental Activities
