# Item (4) BOARDS AND COMMISSION NOMINATIONS

#### (a) Committee on Finance

#### 1. Accommodations Tax Advisory Committee

- ACTION: On behalf of the committee, Councilor Taylor moved to forward the names of John Deck and Joyce Smart to fill the two vacancies on the Accommodations Tax Advisory Committee.
- **ACTION:** Councilor Burns made a motion to close nominations and forward the two nominees to full Council.

Motion carried unanimously with Councilor Seman absent.

#### 2. Arena District

ACTION: On behalf of the committee, Councilor Taylor moved to forward the names of Dee Benedict, Anne Blythe and Steve Sinicropi to fill the three vacancies on the Arena District Board.

Chairman Kirven stated a fourth vacancy was created by a resignation; however the notification was received after the application cycle ended.

**ACTION:** Councilor Payne moved to suspend the rules for posting requirements, so as to allow the fourth vacancy to receive a nomination.

Councilor Meadows stated he would not support Councilor Payne's motion because the additional vacancy would not cause a quorum issue.

Chairman Kirven stated there were several options available to handle the matter.

Councilor Cates asked when new members would start their term.

Mrs. Kizer stated they would begin work after the Governor's approval.

**ACTION:** Councilor Dill moved to go into Executive Session to discuss an issue with the Arena District Board.

Mr. Tollison stated if Councilor Dill was looking for legal advice on a matter, an executive session was appropriate.

Motion carried unanimously with Councilor Seman absent and the Committee of the Whole entered into Executive Session at 5:17 p.m.

#### **RECONVENE**

Mr. Tollison reported Greenville County Committee of the Whole out of Executive Session stating no action was taken. The meeting reconvened at 5:42 p.m.

ACTION:	Councilor Payne moved to request the County Attorney to review policy regarding conflicts of

	to County Council.

Motion to allow the County Attorney to review the policy regarding conflicts of interest as specified in County Policy and in the State Ethics Commission Guidelines and report back to County Council carried unanimously with Councilor Seman absent.

Councilor Baldwin stated there may be citizens that did not apply initially, who may want to apply for the fourth vacancy.

Councilor Payne stated although re-opening the enrollment period for new applicants was a possibility, everyone who was interested had applied initially.

Chairman Kirven stated no one was denied an opportunity to apply.

Councilor Taylor called the question.

Motion to accept the fourth vacancy was approved by a vote of eight in favor (Dill, Burns, Taylor, Kirven, Norris, Rawls, Gibson, Payne), three opposed (Baldwin, Meadows, Cates) and one absent (Seman).

- ACTION: Councilor Taylor nominated Jeff Gilstrap for the fourth vacancy on the Arena District Board.
- **ACTION:** Councilor Meadows nominated Bob Davis for the fourth vacancy on the Arena District Board.
- ACTION: Councilor Payne nominated Stacy Kuper for the fourth vacancy on the Arena District Board.
- ACTION: Councilor Gibson moved to close nominations and forward the nominees to full Council.

Motion carried unanimously with Councilor Seman absent.

# 3. Greenville Area Development Corporation

- ACTION: On behalf of the committee, Councilor Taylor moved to forward the names of Timothy Justice, Mark Kent and Richard Wilkerson to fill the three vacancies on the Greenville Area Development Corporation Board.
- ACTION: Councilor Dill moved to close nominations and forward the nominees to full Council.

Motion carried unanimously with Councilor Seman absent.

- ACTION: Councilor Gibson nominated Oscar Neely to fill the one vacancy on the Recreation District Commission.

Motion carried unanimously with Councilor Seman absent.

# **OTHER**

Councilor Gibson stated the Alcohol and Drug Abuse Commission has had a hard time for the past ten years and she was hoping each existing board member would remain on the committee. She stated her concerns with the Alcohol and Drug Abuse Commission Finance Committee Chairman Batey Kennedy retaining his position.

Chairman Kirven stated because the Alcohol and Drug Abuse Commission nominations were held at the Committee of the Whole and forwarded to full Council, under the Boards and Commissions Policy, no additional nominations were allowed.

ACTION: Councilor Gibson moved to suspend Council Rules to allow for a nomination to the Alcohol and Drug Abuse Commission.

Mr. Tollison suggested a motion to reconsider an action from the last Committee of the Whole meeting would be in order.

Chairman Kirven stated reconsidering the action would set a bad precedence.

**ACTION:** Councilor Gibson withdrew her original motion to suspend the rules and then moved to reconsider the vote taken by the Committee of the Whole on March 6<sup>th</sup> regarding the Alcohol and Drug Abuse Committee.

Councilor Burns stated he remembered going though a similar process previously in the Committee of the Whole relating to a nomination because of the lack of clarity on whom and when nominations

would be allowed. He stated Council Rules would cover a motion for reconsideration.

Motion to reconsider the nominations for the Alcohol and Drug Abuse Commission to allow for an additional nominee carried with eight in favor (Dill, Baldwin, Meadows, Cates, Norris, Gibson, Rawls, Payne), three in opposition (Taylor, Burns, Kirven) and one absent (Seman).

ACTION: Councilor Gibson moved to nominate Batey Kennedy to the Alcohol and Drug Abuse Commission.

Without objection, nominations were closed forwarded to full Council.
