

RESOLUTION

TO HOLD A PUBLIC HEARING TO CONSIDER ENLARGING THE GREATER GREENVILLE SANITATION DISTRICT TO INCLUDE CERTAIN PROPERTIES LOCATED OFF OF LAKE DRIVE AND SANDRA DRIVE AND A PROPERTY LOCATED OFF OF EAST MOUNTAIN CREEK ROAD.

WHEREAS, the Greater Greenville Sanitation District (“District”) was created by Act No. 1543 of the 1968 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, and as such is a special purpose district created prior to March 7, 1973 to which has been committed the function of collecting refuse, garbage and trash within and outside the district, and to engage in the operations of dumps or landfills for the orderly disposal of refuse, garbage and trash within Greenville County; and

WHEREAS, a petition has been submitted to Greenville County Council by the majority of owners of the following real property located in Greenville County to have said property annexed into and made a part of the Greater Greenville Sanitation District:

- A. That certain real property located off of Lake Drive and Sandra Drive described as Greenville County Tax Map Numbers (“TMS#”) 0252000100116, 0252000100203, 0252000100205, 0252000100401, 0252000100701, 0252000100800, 0252000100803, 0252000100804, 0252000100805, 0252000100808, 0252000100809, 0252000100813, 0252000100817, 0252000100818, 0252000103100, and 0252000103200; and
- B. That certain real property located off of East Mountain Creek Road described as Greenville County Tax Map Number (TMS#) P024000200611.
