(a) City View Special Tax District / Creation

A public hearing was held for the purpose of receiving public comments regarding an ordinance to create the City View Special Tax District; to define the boundaries of the District and the purpose for which it is created; to establish the City View Special Tax District as an Administrative Division of Greenville County; and to impose a tax levy of not more than 20 mills annually on all property located within the district.

There being no speakers, Councilor Meadows declared the public hearing closed.

(b) Laurens / Greenville Multi County Industrial Business Park Agreement Amendment - Conpearl North America Inc. (Formerly Project Michigan)

ACTION: Councilor Taylor moved for adoption at third reading an ordinance to amend the Master Agreement governing the Octagon Industrial Park of Laurens and Greenville Counties so as to enlarge the park.

(c) Laurens / Greenville Multi County Industrial Business Park Agreement Amendment - Project Gro

(e) City View Special Tax District / Creation

ACTION: Councilor Meadows moved for adoption at third reading an ordinance to create the City View Special Tax District; to define the boundaries of the District and the purpose for which it is created; to establish the City View Special Tax District as an Administrative Division of Greenville County; and to impose a tax levy of not more than 20 mills annually on all property located within the district.

- AMENDMENT: Councilor Taylor moved to amend the ordinance, the fee agreement and the infrastructure credit agreement to reflect the changes outlined in the red-lined versions provided in the agenda packet.

ADMINISTRATOR'S REPORT

County Administrator Joe Kernell gave Council an update on the County's financial situation for Fiscal Year 2012. He stated the audit was complete and the County Property Tax Revenue was down \$4.9 million; County office revenues were up in Building/Codes by \$515,000; in EMS by \$473,000; in Intergovernmental Revenue by \$1.359 million (which was partly due to the State Aid to Subdivisions funding coming in at a higher amount than budgeted); and other revenues which came in at \$942,000 over budget. The County's overall budgeted revenue was \$129,911,000. Revenues received were \$128,098,000; a difference of \$1.8 million under budget on the revenue side.

On the expenditure side they were able to keep costs down. The County's budgeted expenses were \$128,191,000; monies actually spent were \$126,314,000, making a difference of \$1.877 million.

The projected ending fund balance for 2012 was \$52,155,355. With the savings the County experienced, they were able to increase the fund balance by \$1,783,404 for a surplus of \$52,219,000.

Councilor Dill thanked Mr. Kernell and staff for anticipating a reduction in state funding.

- Councilor Payne stated his gratitude for living in such a great community as Greenville.
