SUBJECT: Enhancement Grant

DATE: October 8, 2012

Greenville County has \$902,465.00 allocated in Enhancement Funds, which may only be used for non-vehicular transportation projects. We are requesting permission to submit a grant proposal to use those funds to conduct streetscape improvements to Poinsett Highway.

The section of the highway to be enhanced with the funds would be the ½ mile stretch between Hammett St. and Gantt St. The proposal would fund the construction design and build of a streetscape plan in accordance with the Poinsett Corridor Revitalization Coalition's concept plan developed by Arbor Engineering.

The total estimated cost for the Poinsett Streetscape Project is \$3,421,340. Currently, Trees Greenville has committed \$84,000.00; Greater Greenville Sanitation has committed \$22,500.00; and, Waste Management has committed \$10,000.00. Staff is still working to determine additional funding as well.

In anticipation of the above costs, we have identified some potential project funding sources to minimize County contributions. For example, Roadway items are estimated to cost \$680,000, which can be applied for through the CTC Committee. Additionally, Enhancement Grant funds for FY 2014 and FY 2015 are estimated to be about \$200,000, which would also be applied for in the future.

In the event that Greenville County is successful in obtaining funding from the CTC for road construction items, the County's obligation will be reduced to \$1,638,875.00. I anticipate this amount coming out of Capital Funding for FY 13 and FY14 at a rate of \$819,437.50 per fiscal year.

Cash Flow Analysis: All enhancement grant funds require a 20% match. County is responsible for paying all invoices and seeking reimbursement from the state, therefore full contract value should be budgeted for obligation and available in FY 2015.
