CALL TO ORDER

Chairman Taylor called the Finance Committee meeting to order at 5:30 P.M.

INVOCATION

Councilor Kirven provided the invocation.

APPROVAL OF MINUTES:

Councilor Burns moved to approve the minutes of the regular meeting of March 12, 2012. The motion carried.

GRANT APPLICATIONS:

FY2013 USED OIL GRANT:

This is the FY2013 Used Oil Grant in the amount of \$9,663. This grant will be used to acquire equipment/supplies and pay for contracts, public education and professional development related to the County's seven oil collection facilities. The grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Meadows moved to approve the FY2013 Used Oil Grant in the amount of \$9,663. The motion carried unanimously

FY2013 WASTE TIRE GRANT:

This is the FY2013 Waste Tire Grant in the amount of \$169,836.49. The grant will fund the Solid Waste Division's contractor costs for current generation tires and provide funds for professional development and public education in the area of waste tire reduction and recycling. The grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Burns moved to approve the FY2013 Waste Tire Grant in the amount of \$169,836.49. The motion carried unanimously.

FY2013 SOLID WASTE REDUCTION AND RECYCLING GRANT:

This is the FY2012 Solid Waste Reduction and Recycling Grant in the amount of \$5,000. This grant will allow the Solid Waste Division to acquire a trailer to transport e-waste from the Residential Waste and Recycling Centers to the Twin Chimneys Landfill to be collected, consolidated and await transport by Creative Recycling.

Ruth Parris, Budget Manager and Wendy McNatt, Recycling Coordinator were present to answer questions of the committee.

Councilor Kirven moved to approve the FY2012 Solid Waste Reduction and Recycling Grant in the amount of \$5,000. The motion carried unanimously.

NORTH GREENVILLE FIRE DISTRICT - TO DECLARE RESULTS OF REFERENDUM:

This is a resolution to declare the results of a referendum held in the North Greenville Fire District on March 20, 2012. The referendum was to determine whether the district will be authorized to issue not exceeding \$1,750,000 in General Obligation Bonds.

Brad Love, Haynsworth Sinkler Boyd was present to answer questions of the committee.

Councilor Meadows moved to approve a resolution declaring the results of a referendum held in the North Greenville Fire District to authorize the issuance of not exceeding \$1,750,000 in General Obligation Bonds. The motion carried unanimously.

GREENVILLE/ANDERSON MULTI-COUNTY PARK AGREEMENT:

This is an ordinance to authorize the eighteenth amendment to the agreement for the development of a Joint County Industrial Park between Greenville County and Anderson County in order to include one or more parcels of property located in Anderson County for Project Palmetto.

Brandon Norris, McNair Law Firm was present to answer questions of the committee.

Councilor Burns moved to approve the ordinance to authorize the eighteenth amendment to the agreement for the development of a Joint County Industrial Park between Greenville County and Anderson County in order to include one or more parcels located in Anderson County for Project Palmetto. The motion carried unanimously.

COMMUNITY PROJECT APPLICATION – SLATER MARIETTA FIRE DEPARTMENT:

This is a Community Project Application from the Slater Marietta Fire Department for the installation of a fire hydrant at Guest Drive. The amount requested is \$3,900.

Councilor Meadows moved to approve the community project application in the amount of \$3,900 from the Slater Marietta Fire Department for the installation of a fire hydrant at Guest Drive. The motion carried unanimously.

PROJECT IKE II:
