COMMUNITY PROJECT APPLICATIONS:

SLATER MARIETTA CHRISTMAS PARADE:

This is a request from the Slater Marietta Fire Department to approve \$1,500 from the Community Project Account to fund the Slater Marietta Christmas Parade.

Councilor Meadows moved to approve the application in the amount of \$1,500 from the Community Project Account to fund the Slater Marietta Christmas Parade. The motion carried unanimously.

TRAVELERS REST CHRISTMAS PARADE:

This is a request from the City of Travelers Rest to approve \$1,500 from the Community Project Account to fund the Travelers Rest Christmas Parade.

Councilor Meadows moved to approve the application in the amount of \$1,500 from the Community Project Account to fund the Travelers Rest Christmas Parade. The motion carried unanimously.

FY2012-2013 ACCOMMODATIONS TAX FUNDING ALLOCATION:

This is a request to approve FY2012-2013 Accommodations Tax funding. The request was held in the Finance Committee on October 8, 2012.

After some discussion, Councilor Meadows moved to amend the reallocation of funds to the following organizations/projects: Freedom Weekend Aloft, Inc. - \$25,000, Greenville Chorale - \$2,500, Greenville Little Theatre - \$7,538, Greenville Symphony Orchestra (Holiday at Peace) - \$5,000, Heritage Foothills Committee/Greater Greenville Recreation District (Dark Corner Oral History Video Project) - \$10,000, NOTUS Sports In Care of Roger C. Peace (2014 UCI Para-Cycling World Championships) - \$19,000, South Carolina Children's Theatre (SCCT) (2012-2013 Season) - \$2,000 and The Children's Museum of the Upstate (Science in Toyland) - \$15,000. A total of \$47,538 would be reallocated. The motion to amend carried a vote of 3 – 1. Councilor Burns was opposed. Councilor Meadows moved to approve the motion as amended. The motion carried a vote of 3 - 1. Councilor Burns was opposed.

EXECUTIVE SESSION:

Councilor Burns moved to go into executive session at 4:24 to discuss a contractual matter. The motion carried unanimously.

This Finance committee came out of executive session at 4:48.

PROJECT GINA:

Councilor Kirven moved to approve a resolution authorizing the execution and delivery of an Inducement and Millage Rate Agreement between Greenville County and Project GINA. The motion carried a vote of 3-1. Councilor Burns was opposed.
