BACKGROUND:

Planning Commission and P & D Committee have, in the past, had dockets for their review needing additional public comment for various reasons. At the last Planning & Development meeting, staff was asked to come up with a way to ensure interested parties would know about any "additional public comment session" held on a zoning docket. Staff believes this could be best accomplished through a policy, which would allow for flexibility in the methods used to publicize the event. Therefore, we are requesting the Planning and Development Committee to consider an amendment to the ordinance, as follows:

3:2.7 Action by County Council

After conducting a duly advertised public hearing, The Planning and Development Committee County Council-shall consider information presented at the <u>public</u> hearing and the staff review and recommendation received from the Greenville County Planning Commission <u>before making</u> <u>a recommendation to County Council</u>. In its recommendation, the Planning Commission may request an additional comment session. The Planning and Development Committee may return the zoning docket to the Planning Commission and require an additional public comment session on the zoning docket based on the Committee's determination or based on the request by the Planning Commission. Should the docket be returned to the Planning Commission for comment purposes, the public comment session shall be held at the next regularly scheduled meeting of the Planning Commission. Staff shall develop a policy to publicize an additional comment <u>session on a zoning docket.</u>

The policy, as currently envisioned, would direct staff to let interested parties who attended the regular public hearing on the docket be notified about any additional public comment sessions. Staff could provide a sign up sheet at the public hearing for anyone interested in being notified of any future public comment sessions.

The policy also would require notification of the additional comment session on the County website. Of course, the additional comment session will be placed on the Planning Commission agenda as well. Other methods of notification could be developed through the policy.
