<u>General Description</u>: Enforcer Foam Fire Systems are extremely versatile portable firefighting systems that utilize high energy compressed foam technology for quick attack on fires. These systems have been approved by both NFPA and UL.

Benefit project will provide the Community: If awarded, these funds would allow The Duncan Chapel Fire District to equip two Quick Response Trucks and a UTV (used to protect The Swamp Rabbit Trail) making them capable of fighting fires. Currently these vehicles have no firefighting capabilities and can only be used for quick response to medical incidents. Equipping these vehicles with firefighting equipment will also allow The Duncan Chapel Fire District to respond quickly to mountainous and other hard to access locations providing a faster attack on fires.

Additional Comments: This equipment can be used to extinguish a variety of fires such as vehicle fires, outside fires, grease or flammable liquid fires, rescues of entrapped victims, etc. The portability of this equipment is more versatile for our mountainous terrain and other hard to access locations. This equipment will also be made available to neighboring fire districts upon request.
