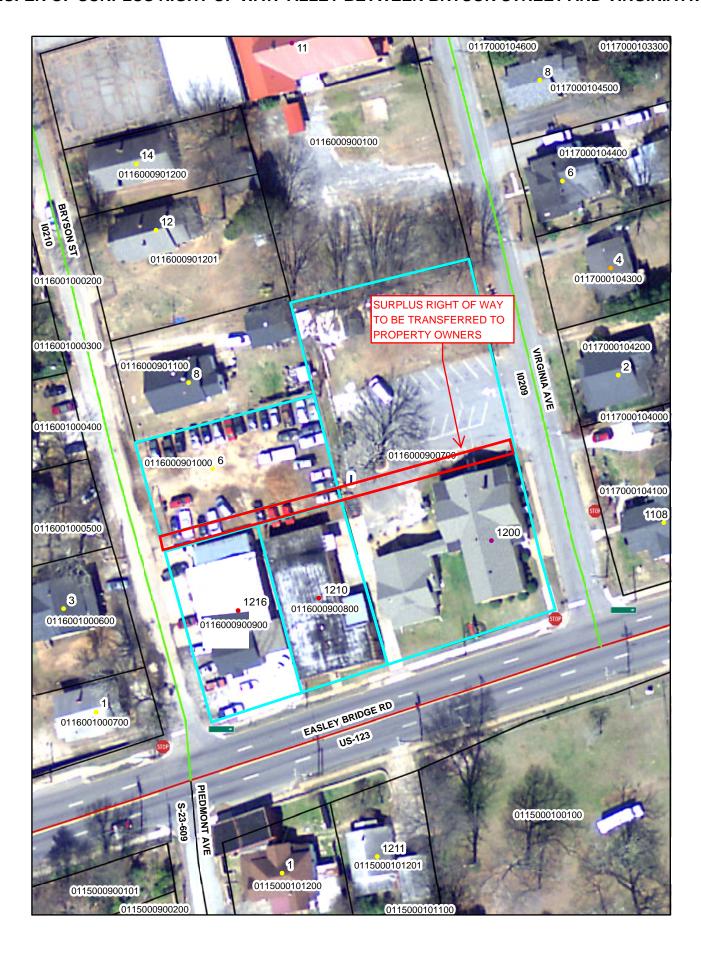
BRIEFLY DESCRIBE PORTION OF RIGHT OF WAY TO BE ACQUIRED IN RELATION TO YOUR ADJOINING PROPERTY:

The Joint Applicants are 3 property owners, Iglesia Pentecostal Jehova Jireh (a Non-Profit SC Corporation, ie a church), Misael Auto Services, LLC and its member, Jose Misael Herrera. Iglesia owns a parcel of property comprised of lots 3, 4, 19 & 20 of an old (1915) subdivision known as Highland on Easley Bridge Road; these lots are now combined into a single TMS #, namely 0116.00-09-007.00. Misael Auto owns lot 5 of Highland (TMS #0116.00-09-008.00) as well as lot 14 (TMS #0116.00-09-010.00. Herrera individually owns lot 6 (TMS #0116.00-09-009.00). The old subdivision plat from 1915 shows an alley 10 feet in width running through the Iglesia property with lot 19 being on one side and lots 3 & 4 being on the other side. This same alley runs through the Misael Auto/Herrera property with lot 14 being on one side and lots 5 & 6 being on the other side. The alley is no longer used by anyone other than these surrounding property owners who respectively treat it as a part of their conveyed properties. It does not appear to have ever been conveyed to any party except to the County by plat dedication but has long been abandoned on the ground; it is not included in the County's road network. The alley leads nowhere and serves no public purpose. The Applicants propose it be formally acquired by the County as a surplus right-of-way and then released to them as the only affected owners of the surrounding properties via quitclaim deeds

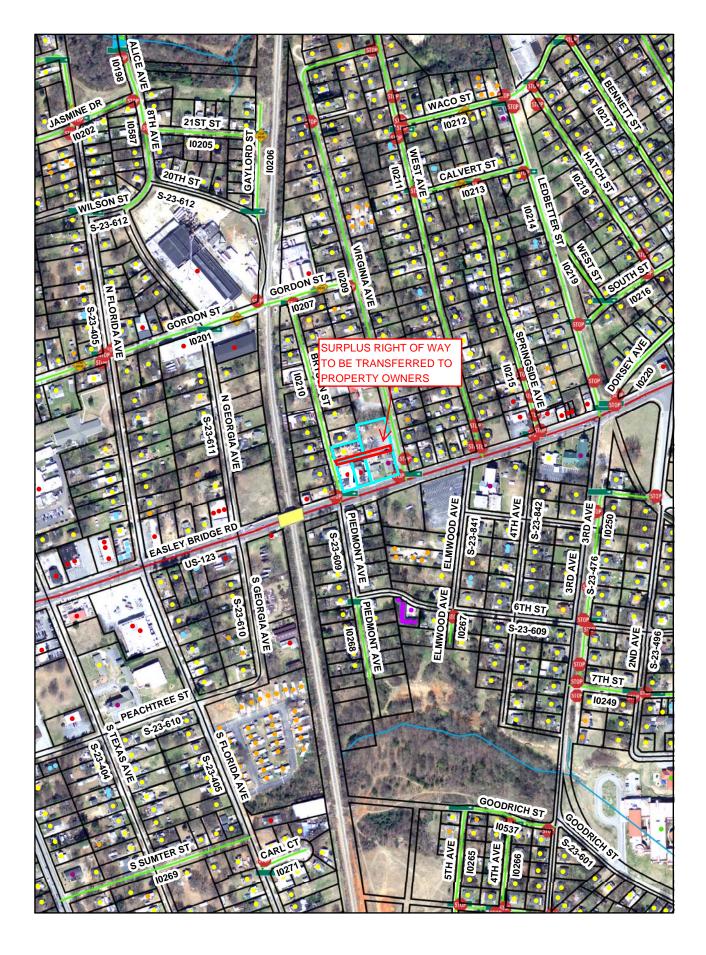

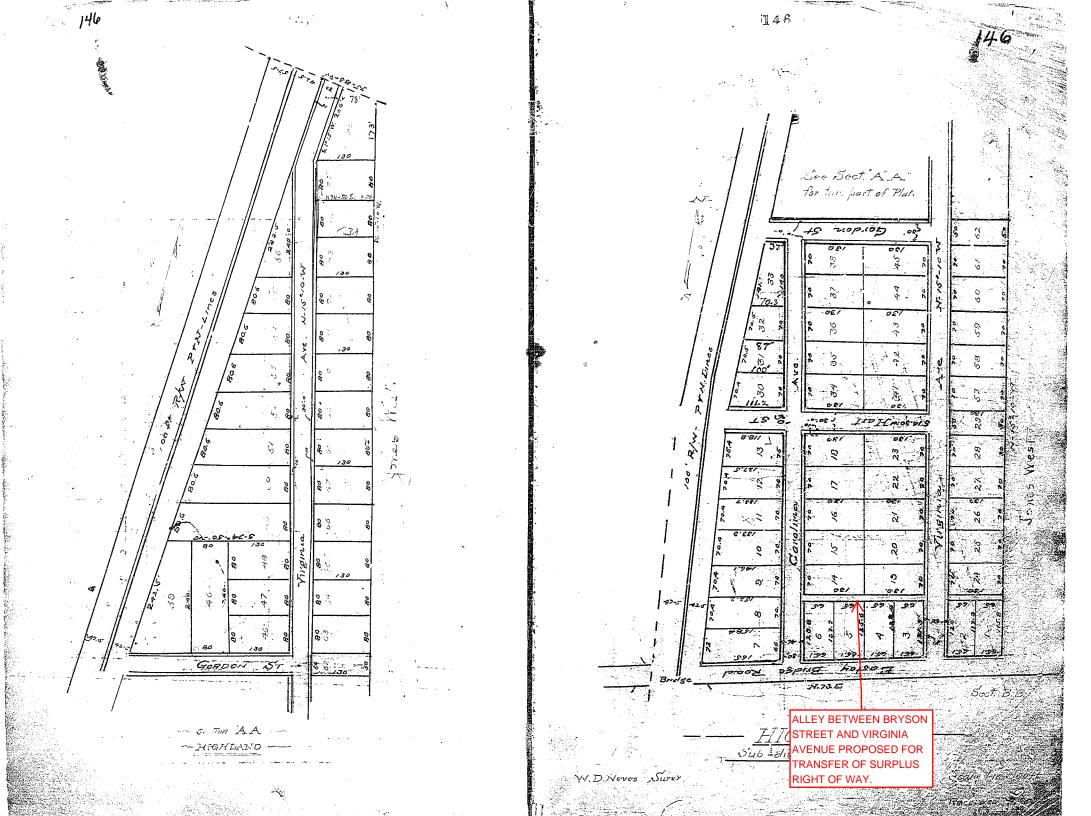

KNOW ALL MEN BY THESE PRESENTS that DEERING MILLIKEN, INC. (formerly The Cotwool Manufacturing Corporation), a corporation duly organized and existing under the laws of the State of Delaware, by donation to GREENVILLE COUNTY, a political subdivision of the State of South Carolina, the receipt of which is hereby acknowledged by the said Greenville County, has granted and conveyed and does hereby grant and convey unto,

GREENVILLE COUNTY, SOUTH CAROLINA:

All those pieces, parcels and strips of land situate, lying and being in the Judson Mill Village near the City of Greenville, in the County of Greenville, State of South Carolina shown as streets and roadways on two plats entitled "Street Layout of Judson Mill Village" made by Piedmont Engineering Service, October 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book 66 at pages 183 and 184, respectively.

Easley Bridge Road, Anderson Road and Valentine Street, shown on the aforementioned plats, are public thoroughfares and are excluded from this conveyance; however, it is the grantor's intention to convey by this deed any and all interest which it may have in all the streets and roadways shown in said plats.

Together with all the right, title and interest of the grantor, however acquired, in perpetual easements

and rights of way for drainage over and across the lands shown on the aforementioned plats (a large part of which have been conveyed by the grantor or its predecessor, Judson Mills, to others) in the locations shown on said plats; together with all the rights of the grantor, however acquired, to enter upon such locations at any time for the purpose of reconstructing, maintaining, repairing and improving open drainage ditches, storm sewers, underground drainage pipelines, mains, culverts, or tile drains, and to excavate and refill ditches for the replacing or repair of said drains, pipelines, culverts and/or mains.

The grantor reserves to itself, its grantees, successors and assigns the perpetual right, privilege and easement to keep and maintain in the aforementioned streets and roadways any and all water, sewer and other utility lines and systems now located therein (together with all apparatus and equipment used in connection therewith), and, from time to time, to install and maintain other such lines and systems in addition thereto or in substitution thereof, including any and all apparatus and equipment used in connection therewith; with the further right to enter upon said streets and roadways at any time for the purposes of installing such other lines and systems and maintaining, repairing, inspecting and operating any and all of the same and doing all things which may be necessary or proper in connection therewith.

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any way incident or appertaining.

TO HAVE AND TO HOLD all and singular, the said premises and easements unto Greenville County, South Carolina, its successors and assigns, forever.

And the said Deering Milliken, Inc. does hereby bind itself, its successors and assigns, to warrant and defend all and singular the said premises unto the said Greenville County, South Carolina, its successors and assigns, against itself and its successors.

Prior to June 13, 1960, the grantor was known as The Cotwool Manufacturing Corporation, but on said date its name was changed to Deering Milliken, Inc.
