

**A RESOLUTION**

**TO HOLD A PUBLIC HEARING TO CONSIDER ENLARGING THE METROPOLITAN SEWER SUBDISTRICT TO INCLUDE THE REAL PROPERTY LOCATED OFF OF SCUFFLETOWN ROAD AND DESIGNATED AS GREENVILLE COUNTY TAX MAP NUMBERS (TMS#) 0548.02-01-020.01, 0548.02-01-020.02, AND 0548.02-01-020.04.**

**WHEREAS**, the Metropolitan Sewer Subdistrict was created by Act No. 687 of the 1969 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, as amended by Act No. 1842 of the 1972 Acts and Joint Resolutions of the General Assembly of the State of South Carolina; and

**WHEREAS**, a petition has been submitted to Greenville County Council by Sue W. Henry the owner of the real property located off of Scuffletown Road and described as Greenville County Tax Map Numbers (TMS#) 0548.02-01-020.01 and 0548.02-01-020.02 and Mark. S. Henry the owner of the real property located off of Scuffletown Road and described as Greenville County Tax Map Number (TMS#) 0548.02-01-020.04 to have said property annexed into and made a part of the Metropolitan Sewer Subdistrict.

**NOW, THEREFORE, BE IT RESOLVED** that a public hearing be held for the purpose of determining whether the Metropolitan Sewer Subdistrict shall be enlarged to include property adjacent to Morton Road and described as Greenville County Tax Map Number (TMS#) 0548.02-01-020.01, 0548.02-01-020.02, and 0548.02-01-020.04.

**A RESOLUTION**

**TO ENLARGE THE BOUNDARIES OF THE METROPOLITAN SEWER SUBDISTRICT TO INCLUDE THE REAL PROPERTY LOCATED OFF OF SCUFFLETOWN ROAD AND DESIGNATED AS GREENVILLE COUNTY TAX MAP NUMBERS (TMS#) 0548.02-01-020.01, 0548.02-01-020.02, AND 0548.02-01-020.04, AND TO PROVIDE FOR PUBLIC NOTICE THEREOF.**

**WHEREAS**, pursuant to Section 6-11-410, et seq., of the Code of Laws of South Carolina, 1976, as amended (“S.C. Code Ann.”), the governing bodies of the several counties of the State are authorized to enlarge, diminish or consolidate any existing special purpose districts located within such counties; and the Greenville County Council is the governing body of Greenville County, South Carolina;

**WHEREAS**, the Metropolitan Sewer Subdistrict was created by Act No. 687 of the 1969 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, as amended, and as such is a special purpose district created prior to March 7, 1973 to which has been committed the function of acquiring, constructing, operating, maintaining, improving, and extending facilities for the orderly collection of sewage within the boundaries of the Subdistrict and the transmission of the same to the trunk and treatment facilities of Western Carolina Regional Sewer Authority (formerly Greenville County Sewer Authority) for treatment and disposal;

**WHEREAS**, Sue W. Henry the owner of the real property located off of Scuffletown Road and described as Greenville County Tax Map Numbers (TMS#) 0548.02-01-020.01 and 0548.02-01-020.02 and Mark. S. Henry the owner of the real property located off of Scuffletown Road and described as Greenville County Tax Map Number (TMS#) 0548.02-01-020.04, a copy of a map showing these properties is attached as “Exhibit A”, have petitioned to annex these properties into the Metropolitan Sewer Subdistrict;

**WHEREAS**, Metropolitan Sewer Subdistrict has consented to the annexation;

**WHEREAS**, the Greenville County Council finds that the property described in Exhibit A is located wholly within the boundaries of Greenville County, South Carolina and wholly within the boundaries of the Western Carolina Regional Sewer Authority but is not within any special purpose district or municipality which is empowered to accept and maintain lateral and collector lines for the transmission of sewage and waste to the trunk and treatment facilities of the Western Carolina Regional Sewer Authority; that annexing such property into the Metropolitan Sewer Subdistrict would extend the facilities for the orderly collecting of sewage within the boundaries of the Subdistrict; and

**WHEREAS**, Greenville County Council finds that it is in the public interest that the

boundaries of said Subdistrict be enlarged so as to include the property described in Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED** by Greenville County Council that the boundaries of the Metropolitan Sewer Subdistrict are hereby enlarged to include the real property described as Greenville County Tax Map Numbers (TMS#) 0548.02-01-020.01 and 0548.02-01-020.02 located off of Scuffletown Road and owned by Sue W. Henry, and the real property described as Greenville County Tax Map Number (TMS#) 0548.02-01-020.04 also located off of Scuffletown Road and owned by Mark. S. Henry, as shown in Exhibit A of this Resolution; and that pursuant to S.C. Code Ann. §6-11-470, as amended, the Clerk of the County Council shall cause to be published in a newspaper of general circulation in Greenville County, once a week for two successive weeks the following information:

- (a) the results of this action of the Greenville County Council;
- (b) the fact that this Resolution does not authorize the issuance of additional bonds by the Metropolitan Sewer Subdistrict; and
- (c) the fact that there will be no new Commission or changes made in the personnel of the present Commission of the Metropolitan Sewer Subdistrict.
