**Item (3) Approval of the Minutes of the Regular Meeting of PWI Committee on November 5, 2013**

**ACTION:** Councilor Xanthe Norris moved to approve the November 5, 2013, Public Works and Infrastructure Committee minutes as submitted.

By voice vote the motion carried unanimously by all Council Members present.

**Item (4) Water Line Grant Assistance on Bessie Rd to Young Dr for Erion Rosemond**

Paula Gucker, Assistant County Administrator for Community Planning, Development & Public Works addressed the Committee Members concerning this request. Mrs. Gucker explained that the county received an application from Ms. Erion Rosemond for assistance with a 60 foot extension on Bessie Road to her property. Mrs. Gucker explained that this is a 50/50 grant with the citizen paying 50%. The total cost of the project was \$1,800 and Ms. Rosemond had submitted her check for \$900. Mrs. Gucker provided a map and pointed out where the current water line now ends and where they would extend it to provide a water main to Ms. Rosemond's property at 10 Young Dr.

Chairman Fred Payne thanked Mrs. Gucker for the presentation and stated that this was one of the clearest explanations of what was requested that he had ever heard.

**ACTION:** Councilor Jim Burns moved to recommend Council approval of the water line grant assistance on Bessie Road/Young Dr. for the county's 50% or \$900.

By voice vote the motion carried unanimously by all Council Members present.

**Item (5) Proposed Relinquishment of a Portion of Park avenue (K0062)**

Hesha Gamble, County Engineer, explained to the Committee Members that they received a request from the property owners for the County to relinquishment of a portion of Park Avenue (K0062) off Geer Hwy. The request was to relinquish maintenance of approximately 1,724 SF of Park Avenue. Mrs. Gamble pointed out the location on a map and stated that few of the citizens on Park Avenue used this intersection because of the difficulty turning. Mrs. Gamble stated that this was not an optimal intersection and what is being proposed would close this intersection and provide safer access to the property.

**ACTION:** Councilor Joe Baldwin moved to recommend Council approval of the proposed relinquishment of a portion of Park Avenue (K0062) and to hold a public hearing.

By voice vote the motion carried unanimously by all Council Members present.

Chairman Fred Payne stated that he received a message from Councilor Butch Kirven that he had an earlier appointment out of town and was running late.
