AN ORDINANCE TO AMEND AN AGREEMENT FOR THE DEVELOPMENT OF A JOINT COUNTY INDUSTRIAL AND BUSINESS PARK (2010 PARK) OF ANDERSON AND GREENVILLE COUNTIES SO AS TO ENLARGE THE PARK.

WHEREAS, pursuant to Ordinance No. 4391 enacted October 19, 2010 by Greenville County Council, Greenville County entered into an Agreement for the Development of a Joint County Industrial and Business Park (2010 Park) dated as of December 1, 2010, as amended, with Anderson County (the "Agreement"); and

WHEREAS, pursuant to Section 3(A) of the Agreement, the boundaries of the park created therein (the "<u>Park</u>") may be enlarged pursuant to ordinances of the County Councils of Anderson County and Greenville County; and

WHEREAS, in connection with certain incentives being offered by Anderson County to Duke Energy Carolinas, LLC, it is now desired that the boundaries of the Park be enlarged to include certain parcels in Anderson County;

NOW, THEREFORE, be it ordained by Greenville County Council that <u>Exhibit B</u> to the Agreement is hereby and shall be amended and revised to include the property located in Anderson County described in the schedule attached to this Ordinance, and, pursuant to Section 3(B) of the Agreement, upon adoption by Anderson County Council of a corresponding ordinance, the Agreement shall be deemed amended to so include such property and <u>Exhibit B</u> as so revised, without further action by either county.

PARCEL 1:

FIRST: All that certain parcel of land, in Williamston School District No. 20 Belton Township, Anderson County, State of South Carolina shown and represented as Tract No. 2 on a plat made of the property of Wilson's Estate on December 9, 1940, by J. A. Pickens, Surveyor, and having the distances, metes and bounds as shown on said plat, which is recorded in Plat Book 14 at page 39, the office of the Clerk of Court for Anderson County, South Carolina. This tract of land is bounded on the North by Tract #3 shown on the above mentioned plat and on the South and the East by Tract #4, shown on the above mentioned plat. This tract of land contains 4.30 acres, more or less, and is one of the parcels conveyed to Duke Power Company from T.G. Austin by deed dated April 14, 1948 and recorded in the Office of the Clerk of Court of Anderson County, South Carolina in Deed Book I-8 at page 178 and is one of the parcels of land conveyed to T. G. Austin from George S. Wilson, Executor, et al by deed dated December 16, 1940, and recorded in the Office of the Clerk of Court for Anderson County, South Carolina in Deed Book D-7 at page 439.

SECOND: All that certain parcel of land in Williamston School District No. 20, Belton Township, Anderson County, State of South Carolina, being known and represented as Tract #3 on a plat made of the property of Wilson's Estate on December 9, 1940 by J. A. Pickens, Surveyor, recorded in Plat Book 14 at page 39 in the Clerk of Court's office for Anderson County and containing 32 acres more or less. This tract of land is bounded as follows: on the North by lands now or formerly of J. A. Dacus and the Saluda River, on the East by the Saluda River, on the South by Tract #4 as shown on said plat, on the West by Tract #2 shown on said plat and the lands now or formerly of J. A. Dacus. Said land is one of the parcels conveyed to Duke Power Company from T.G. A. Dacus, J. A. Copeland and others and being the same tract of land conveyed to Duke Power Company from J. Albert Copeland by deed dated September 15, 1948 and recorded in the Office of the Clerk of Court of Anderson County, South Carolina in Deed Book 7-Z at page 619 and being the same tract of land conveyed to Albert Copeland from Ethel Smith by deed dated July 5, _____ (said deed being probated July 5, 1945 and recorded July 12, 1945) and recorded in the Office of the Clerk of Court for Anderson County, South Carolina in Deed Book V-7, page 53. This tract of land was inherited by said Ethel Smith and her sister, Dicy Smith, from their father, J. H. Smith, the said Dicy Smith having married W. C. Holliday and subsequently died leaving as her sole heirs at law and distributes her husband and Ethel Smith, to whom W. C. Holliday conveyed his interest in said land by deed of record in said Clerk of Court's office in Deed Book T-7, page 493.

PARCEL 3:

All that piece, parcel or tract of land, situate, lying and being in Williamston and Belton Townships, in the County of Anderson, State of South Carolina, on the bank of the Saluda River, containing 239.57 acres, more or less, as shown on a plat entitled Duke Power Company Addition to Lee Steam Station Property dated August 4, 1971 and recorded in the Office of the Clerk of Court for Anderson County in Plat Book 76 at Page 433, said tract herein conveyed having the metes, bounds, courses and distance as are shown upon said plat which is incorporated herein and made a part hereof by reference. As shown on said plat, the tract herein conveyed is bounded on the North by S. C. Road No. S-212, property now or formerly of Dunlap, property now or formerly of Anderson and Saluda River; on the East by property now or formerly of Duke Power Company (Lee Steam Station); on the South by property now or formerly of Mark; and on the West by S. C. Road No. S-116, property now or formerly of Kelly, property now or formerly of Cothran, and property whose owners are unknown.
