SUBJECT:	Relinquishment of approximately 465' of Old Watson Mountain Road Spur (R0076)

This Division received a request from the property owner referenced as TMS# 0663010101601 to relinquishment maintenance of Old Watson Mountain Road Spur to him for use as his private driveway. Mr. Morgan is the only property owner adjacent to the road. His property also fronts Old Watson Mountain Road (R0075) and Beaver Dam Road (S-23-177). The County accepted Old Watson Mountain Road Spur into our road inventory by prescription during the mass acceptance on 12/07/1982 at a length of 465'.

Staff is requesting Council's approval to relinquish maintenance of Old Watson Mountain Road Spur, transfer the ownership of the right of way to the adjoining property owner and a motion to proceed with a public hearing.


