#### APPROVAL OF MINUTES

## UPDATE OF SPECIAL PROPERTY TAX ASSESSMENTS RELATED TO REHABILITATED HISTORIC PROPERTY - BAILEY BILL:

This is an ordinance to update and provide for the Special Property Tax Assessments authorized by Section 4-9-195 of the South Carolina Code of Laws as to real property which qualifies as "Rehabilitated Historic Property"; to repeal Ordinance No. 2709; and other matters related thereto.

Mark Tollison, County Attorney and Kimberly Wunder, Assistant County Attorney were present to answer questions of the committee.

Councilor Kirven moved to approve ordinance to update and provide for the Special Property Tax Assessments authorized by Section 4-9-195 of the South Carolina Code of Laws as to real property which qualifies as "Rehabilitated Historic Property"; to repeal Ordinance No. 2709; and other matters related thereto.
