- 7. PROJECT DESCRIPTION:
 - a. This year, the Greenville County Redevelopment Authority was awarded a \$400,000 EPA Brownfield Clean-up Grant to make the former Poe Mill textile site ready for reuse as new skate park and recreational facility. In anticipation of this investment, the New Poe Mill Neighborhood Association in partnership with the Sheriff's Department has put forth the Poe Mill Gateway: Mural Project, a component of a larger community revitalization strategy, to improve the intersection of Buncombe Road and Shaw Street-a major gateway to Poe Mill and its proposed park. By implementing Crime Prevention Through Environmental Design Concepts and Strategies (CPTED), the Mural Project seeks to bolster the social, cultural and economic vibrancy of the Poe Mill Village and its gateway. Specifically, the project consists of the installation of one wall mural with a human element on the facade of a convenience store located at the intersection of Shaw Street and Buncombe Road. Wall murals with human elements are known to create the "feeling" and illusion of "more eyes on the street" thereby deterring criminal activity. Research has also shown that cultural resources in neighborhoods like murals contribute to "sustaining neighborhoods by stabilizing property values" and "lower levels of social stress in children."
 - b. BENEFIT PROJECT WILL PROVIDE THE COMMUNITY.

The intersection of Shaw Street and Buncombe Road serves as the front door into the Poe Mill Subdivision. However, the uninviting aesthetic appeal and concentration of criminal activity at this corner creates an impediment for attracting new investments, families searching for affordable housing and future visitors as the community plans to become the home of a new skate park and recreational facility. In short, this corner intimidates and casts a poor perception of Poe Mill to its residents and the greater community at large. According to a community survey conducted in 2009 and numerous neighborhood public meetings in 2011, crime is the number one concern of Poe Mill residents. Additionally, the Shaw Street/Buncombe Road Gateway is often cited as a barrier to developing housing by many local nonprofit affordable housing developers since families are unwilling to buy or rent where there is an embedded perception of crime. According to the Greenville County Crime Incident Mapping System, there is a problem with open drug trafficking, loitering, and prostitution which is concentrated at the subject location. While crime statistics have decreased significantly in this area since 2007, actual crimes and the perception of crime infestation continues to break the social contract of trust in the neighborhood and deters new investment. The Mural Project serves to impact the community by showcasing the neighborhood's history and culture to restore and reinforce

community pride, deter criminal activity and create a better more vibrant "sense of place." The overall goal of the project is to improve morale amongst residents, reduce crime, increase hope regarding the future of the neighborhood and increase resident involvement in community improvement initiatives.
