CALL TO ORDER

Chairman Meadows called the Finance Committee meeting to order at 5:35 p.m.

INVOCATION

Councilor Cates provided the invocation.

APPROVAL OF MINUTES

Councilor Kirven moved to approve the minutes of the regular meeting of May 12, 2014. The motion carried unanimously.

GRANT APPLICATIONS:

FY2014 NATIONAL INSTITUTE OF JUSTICE DNA BACKLOG REDUCTION PROGRAM GRANT:

This is the FY2014 National Institute of Justice DNA Backlog Reduction Program Grant in the amount of \$100,000. This grant would fund overtime and associate benefits as well as supplies and consultant fees for the DNA Lab which expand services, reduce backlog and provide continuing education. This grant does not require a County match.

Ruth Parris, Budget Manager, and Dr. Kandala, DNA Lab were present to answer questions of the committee.

Councilor Kirven moved to approve the FY2014 National Institute of Justice DNA Backlog Reduction Program Grant in the amount of \$100,000. The motion carried unanimously.

BULLETPROOF VEST PARTNERSHIP GRANT:

This is the Bulletproof Vest Partnership Grant in the amount of \$9,769.72. The grant would allow the Forensic Division to purchase 17 bulletproof vests to be used by the Crime Scene Section. The grant requires a 50% County match (\$4,884.86).

Ruth Parris, Budget Manager, was present to answer questions of the committee.

Councilor Cates moved to approve the Bulletproof Vest Partnership Grant in the amount of \$9,769.72. The motion carried unanimously.

ENHANCED DUI ENFORCEMENT GRANT:

This is the Enhanced DUI Enforcement Grant in the amount of \$94,336. The grant will fund an additional DUI Deputy and equipment for enhanced DUI enforcement for one year. The grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Kirven moved to approve the Enhanced DUI Enforcement Grant in the amount of \$94,336. The motion carried unanimously.

FY2013 ASSISTANCE TO FIREFIGHTERS GRANT:

This is the FY2013 Assistance to Firefighters Grant in the amount of \$150,000. This grant will be used to replace one ambulance for the Emergency Medical Services Division. This grant requires a County match of \$15,000.

Ruth Parris, Budget Manager, and Tim Gault, Director of EMS were present to answer questions of the committee.

Councilor Cates moved to approve the FY2013 Assistance to Firefighters Grant in the amount of \$150,000. The motion carried unanimously.
