# **CALL TO ORDER**

# APPROVAL OF MINUTES

Councilor Burns moved to approve the minutes of the regular meeting of September 29, 2014. The motion carried unanimously.

# **GRANT APPLICATIONS:**

# **FY2015 EMS GRANT-IN-AID:**

This is the SC DHEC – EMS Grant-In-Aid in the amount of \$33,855.52. The grant will allow the Emergency Medical Services Division to acquire stretchers, stair chairs, laptop computers and medical floor mount IV fluid warmers. This grant requires a County match of \$1,862.05.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Burns moved to approve the SC DHEC EMS Grant-In-Aid Grant in the amount of \$33,855.52. The motion carried unanimously.

### **ENHANCED DUI ENFORCEMENT GRANT:**

This is the Enhanced DUI Enforcement Grant in the amount of \$56,407. The grant will fund a Deputy position for enhanced DUI enforcement for one year. This grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Kirven moved to approve the Enhanced DUI Enforcement Grant in the amount of \$56,407. The motion carried unanimously.

#### LIVEWELL GREENVILLE MINI-GRANTS:

This is the Livewell Greenville Mini-Grants in the amount of \$4,500 which will be divided between four community centers: Slater-Marietta Afterschool Program - \$1,100, Mt. Pleasant Community Center - \$1,200, Freetown Community Center - \$1,000 and Brutontown Community Center - \$1,200. These minigrants will allow the Community Centers in the Parks, Recreation and Tourism Department to coordinate an intramural sports league among its four afterschool programs. This grant does not require a County match.

Ruth Parris, Budget Manager was present to answer questions of the committee.

Councilor Burns moved to approve the Livewell Greenville Mini-Grants in the amount of \$4,500. The motion carried unanimously.

#### DEPARTMENT OF NATURAL RESOURCES GRANT:

This is the Department of Natural Resources Grant (Saluda River Property) in the amount of \$175,000. This grant will allow the Parks, Recreation, and Tourism Department to purchase property to develop the first public park along the Saluda River. This grant requires a County match of \$117,622.96 which will be provided from the PRT fund balance.

Ruth Parris, Budget Manager, Gene Smith and Ty Houck, Parks, Recreation, and Tourism Department were present to answer questions of the committee.

Councilor Taylor moved to approve the Department of Natural Resources Grant (Saluda River Property) in the amount of \$175,000. The motion carried unanimously.

#### ACCOMMODATIONS TAX FUNDING RECOMMENDATION:
