By ballot vote, the applicants Renita Barksdale, Jane Daniel, Audrey Pasin and Louise Poole were elected to fill the four vacancies on the Greenville County Alcohol and Drug Abuse Commission.

ACTION: Councilor Dill made a motion to close nominations.

Motion to close nominations carried.

The vote was tied with six in favor of Councilor Burns (Burns, Norris, Gibson, Ballard, Dill, Meadows) and six in favor of Councilor Cates (Cates, Taylor, Seman, Kirven, Payne, Baldwin).

Chairman Taylor stated there was one seat open for a Council Member on the Greenville Area Development Corporation Board.

- ACTION: Councilor Norris nominated Councilor Burns to the Greenville Area Development Corporation Board
- **ACTION:** Councilor Kirven nominated Councilor Cates to the Greenville Area Development Corporation.
- ACTION: Councilor Dill made a motion to close nominations.

Motion to close nominations carried.

Councilor Burns and Councilor Cates each gave a brief statement indicating their reasons for seeking appointment to the Greenville Area Development Corporation Board.

By a vote of seven in favor of Councilor Burns (Burns, Norris, Gibson, Ballard, Dill, Seman, Meadows) and five in favor of Councilor Cates (Cates, Taylor, Kirven, Payne, Baldwin) Councilor Burns was appointed to fill the Council Member seat on the Greenville Area Development Corporation.

Item (5) SUNDAY ALCOHOL SALES REFERENDUM

Councilor Gibson stated people had the right to vote on the issue of Sunday alcohol sales. She stated people in the county should have the same privileges as people in the city.

Councilor Burns stated the ordinance was modeled after the ordinances used in the municipalities, and the ordinance passed in all the municipalities. He stated county businesses were at a disadvantage.

Councilor Norris stated this was a personal choice and she would rather people have the opportunity to buy alcohol legally rather than illegally.

Chairman Taylor stated he was opposed to Sunday alcohol sales. He has seen the devastating affect alcohol has on communities and families as well as the costs involved.

Councilor Dill stated he did not support alcohol sales in any form but would not stand in the way of allowing the people to decide. He stated his opinion was based on personal experiences. People were tired of homes and lives being destroyed because of alcohol and of the added millions of dollars of taxpayers' money that was spent to battle the effects of alcohol. People should be allowed to vote their convictions.

Councilor Payne stated he was in favor of the referendum.

By a vote of eight in favor (Burns, Norris, Seman, Gibson, Kirven, Payne, Dill, Baldwin) and four in opposition (Cates, Taylor, Ballard, Meadows) the ordinance was approved.
