Item (14)

ADMINISTRATOR'S REPORT

County Administrator Joe Kernell updated Council members on the Poinsett Project. He stated over the last couple of years the Committee had been trying to come up with a streetscape plan for the Gateway into the City. To date, there have been three grants received for the purpose of funding the Poinsett Project: Transportation Alternative Projects Grant (Federal Highway Administration) in the amount of \$795,000; Appalachian Regional Commission Grant (Department of Commerce) in the amount of \$500,000; and the Greenville Legislative Delegation C-Fund Committee Grant in the amount of \$250,000, bringing the total to \$1.45 million. He stated they have been instructed to apply for an additional \$250,000 from the next round of C-Fund allocations and were looking into a couple of other grants that appeared favorable.

Item (15) REQUESTS AND MOTIONS BY COUNCIL MEMBERS

- Councilor Cates stated he had the privilege of attending the Sheriff's Award Ceremony. He reported
 that in the past year, five law enforcement officers in the Sheriff's Office had faced death in the course
 of their duties. He expressed his appreciation for all public safety officials; law enforcement, fire
 fighters and EMS.
- Councilor Burns stated he had attended a luncheon given by the Homebuilders Association where a speaker talked about the growth of housing in Greenville County. Mr. Burns stated he was concerned about how the County's infrastructure was going to support all the new housing that would be coming. He felt Council needed to look into the matter of water, sewer and stormwater, not just roads and bridges, in order to proactively address the growth.
- Councilor Norris stated the Sterling Center MLK Day celebration was a great event and was well attended. She thanked the Recreation District for all the work they had done to make the Sterling Center a wonderful building. She stated on Friday, February 6th, she and Ms. Gibson would be recognized at a breakfast event for their contributions to the community. She invited her colleagues to the event. Ms. Norris then stated she had been working with the speaker, Ms. Atkins, regarding the issue involving her church on Highway 123. She stated she had staff looking into the matter and they were working very hard toward a solution.
- Councilor Seman stated Jody Bryson was a featured speaker at the International Economic Development Council (IEDC) Annual Leadership Forum. IEDC, a non-profit, non-partisan membership organization with more than 4500 members serving economic developers is the largest organization of its kind. Mr. Bryson was invited to present the case study of the rebranding of the Donaldson Center into the SC Technology and Aviation Center. The opportunity provided national exposure for SCTAC and for Greenville. Ms. Seman then thanked staff for their efforts in presenting the workshop and hoped there would be additional workshops in their future.
- Chairman Taylor stated there would be two more scheduled Council workshops; one more in February and one in early March.
- Councilor Gibson stated the group that had been sponsoring the MLK Day activities would no longer sponsor the banquet. She stated representatives from several organizations were coming together to take on the responsibility of the banquet and other activities that would be in the spirit of Dr. King.
- Councilor Ballard thanked Mr. Kernell and staff for the time spent in presenting a good workshop. He stated he held a Town Hall Meeting the past Thursday that was very productive and he thanked all those who came out to participate.

Greenville County Council February 3, 2015

- Councilor Gibson stated Duke Energy was holding a residential service in Greenville for anyone who would like to have their house weatherized. She stated they were sharing free lightbulbs and taking care of cracks in houses. She stated anyone interested in participating in the program needed to call Duke Energy to get on the schedule.
- Councilor Payne thanked Chairman Taylor and Mr. Kernell for a great workshop. He stated they all had special interests and questions and he felt like a lot of those questions were answered.
- Councilor Kirven reiterated his having noticed a great deal more trash on the roads and he asked for suggestions on how to address that issue. He stated the Clerk was organizing a meeting with Palmetto Pride and other groups to come together and brainstorm the matter. He asked the public for their involvement in the process as well. Mr. Kirven recognized those members in the audience who were with a fire department and expressed his appreciation of the work they performed in the community. Mr. Kirven then sent get well wishes to Joel Dill who was under the weather and reminded everyone of Valentines' Day coming up on the 14th.
- Councilor Baldwin thanked the Sheriff for the invitation to the Awards Banquet stating he very much
 enjoyed the event. He also thanked the First Baptist Church in Taylors for making their facility
 available for the event.
- Councilor Dill stated he had spoken with many of the fire chiefs regarding the matter of EMS and they
 were unappreciative of being left out of the change. He asked the County Administrator to get with the
 fire chiefs to inform them of what was going on and how it would affect their departments. He also
 asked the Chairman to schedule, not a workshop, but a meeting time to discuss EMS.
- Councilor Dill wished Councilors Baldwin, Payne and Seman a Happy Birthday.
