

**AN ORDINANCE**

**TO CREATE THE WILLIAMSBURG DRIVE SPECIAL TAX DISTRICT; TO DEFINE THE BOUNDARIES OF THE DISTRICT AND THE PURPOSE FOR WHICH IT IS CREATED; TO ESTABLISH THE DISTRICT AS AN ADMINISTRATIVE DIVISION OF GREENVILLE COUNTY; AND TO IMPOSE A TAX LEVY OF NOT MORE THAN FORTY-EIGHT DOLLARS (\$48.00) ANNUALLY ON ALL REAL PROPERTY LOCATED WITHIN THE DISTRICT.**

**BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:**

**Section 1. Findings.** Pursuant to Section 4-9-30(5)(a)(ii) of the Code of Laws of South Carolina 1976, as amended, seventy-five percent (75%) of the resident freeholders owning seventy-five percent (75%) of the assessed valuation of the real property in the proposed Williamsburg Drive Special Tax District submitted a petition to Greenville County Council requesting that an ordinance be enacted to establish a special tax district for certain purposes hereinafter set forth, and that a maximum uniform service charge not to exceed Forty-Eight Dollars (\$48.00) be placed on all real property located within the boundaries of the District. The petition has been verified as meeting the requirements for the formation of a special tax district.

**Section 2. Creation of Special Tax District.** There is hereby created the Williamsburg Drive Special Tax District, the boundaries of which include the following properties:

A copy of a map showing these parcels and the boundaries of the Williamsburg Drive Special Tax District is attached hereto as *Exhibit A*:

**Section 3. Purpose.** The purpose and function of the Williamsburg Drive Special Tax District herein established shall be as follows:

To provide for the health, safety, and welfare of its citizens by funding the costs of street lighting within the District.

**Section 4.**     **Administrative Division of Greenville County.** The Williamsburg Drive Special Tax District shall be operated as an administrative division of Greenville County.

**Section 5.**     **Uniform Service Charge.** The Auditor and Tax Collector of Greenville County are hereby directed to assess and collect a uniform service charge of not more than forty-eight dollars (\$48.00) annually on all real property within the Williamsburg Drive Special Tax District. All monies collected from this uniform service charge shall be credited to the District.

**Section 6.**     **Contract Rates.** The provision of lighting is being acquired by agreement with the electric utility provider in the area. Should utility rates increase, the County may re-establish a new maximum service charge in order to maintain lighting within the District.

**Section 7.**     **Effective Date.** This ordinance shall take effect upon its adoption.
