NOTICE IS HEREBY GIVEN that the Greenville County Council, will conduct a public hearing on the proposed adoption of an Ordinance entitled "AN ORDINANCE TO PROVIDE FOR THE ISSUANCE AND SALE OF (I) NOT EXCEEDING ELEVEN MILLION DOLLARS (\$11,000,000) GREENVILLE COUNTY, SOUTH CAROLINA GENERAL OBLIGATION REFUNDING BONDS, SERIES 2016A; (II) NOT EXCEEDING ONE MILLION THREE HUNDRED THOUSAND DOLLARS (\$1,300,000) GREENVILLE COUNTY, SOUTH CAROLINA GENERAL OBLIGATION REFUNDING BONDS (FOUNTAIN INN FIRE SERVICE AREA PROJECT), SERIES 2016B; AND (III) NOT EXCEEDING ON MILLION FIVE HUNDRED THOUSAND DOLLARS (\$1,500,000) GREENVILLE COUNTY, SOUTH CAROLINA GENERAL OBLIGATION REFUNDING BONDS, SERIES 2016C; TO PRESCRIBE THE PURPOSES FOR WHICH THE PROCEEDS SHALL BE EXPENDED; TO PROVIDE FOR THE PAYMENT THEREOF; AND OTHER MATTERS RELATING THERETO" on March 1, 2016 in the Chambers of County Council, County Square, 301 University Ridge, Greenville, South Carolina 29601, at 6:00 p.m. The above-referenced Bonds will be used to refund a portion of Greenville County's (i) \$10,000,000 original principal amount General Obligation Bonds, Series 2008C, dated September 16, 2008, (ii) \$5,615,000 original principal amount General Obligation Bonds, Series 2011A, dated July 26, 2011, (iii) \$461,147 original principal amount General Obligation Bond. Series 2013D, dated September 23, 2013, (iv) \$1,865,000 original principal amount General Obligation Bond (Fountain Inn Fire Service Area Project), Series 2007, dated November 13, 2007 and (v) \$2,545,000 original principal amount General Obligation Bonds (Mauldin Fire Service Area Project), Series 2008A, dated August 5, 2008.

For the payment of the principal of and interest on the Bonds authorized by said Ordinance, there shall be pledged the full faith, credit and taxing power of the County and there shall be levied (i) in the County with respect to the Series 2016A Bonds, (ii) in the Fountain Inn Fire Service Area with respect to the Series 2016B Bonds, (iii) in the Mauldin Fire Service Area with respect to the Series 2016C Bonds, ad valorem taxes sufficient in amount to pay said principal and interest on the Series 2016A Bonds, the Series 2016B Bonds and the Series 2016C Bonds, respectively.

At the time and place fixed for said public hearing all taxpayers, residents or other interested persons who appear will be given an opportunity to express their views for or against the adoption of the Ordinance.
