## AN ORDINANCE

TO AUTHORIZE AND APPROVE THE TRANSFER OF COUNTY OWNED PROPERTY LOCATED AT 301 RIVER STREET, TO AUTHORIZE THE EXECUTION OF DEEDS AND ANY OTHER APPROPRIATE DOCUMENTS AND AGREEMENTS RELATED THERETO, AND ESTABLISHES USE OF TRANSFER PROCEEDS.

NOW, THEREFORE, BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Authorize Transfer. The Chairman of Greenville County Council and the County Administrator are hereby authorized to execute, on behalf of the County of Greenville, deeds between the County of Greenville, as Grantor, and Paul C. Aughtry, III or his assigns, as Grantee, for the purpose of conveying the County's interest in the real property located at 301 River Street, Greenville, South Carolina 29601. The property to be transferred is more fully described in Exhibit "A". The Chairman of County Council and the County Administrator are further authorized to execute any other appropriate documents and agreements necessary for the transfer of the property.

<u>Section 2.</u> <u>Proceeds of Sale.</u> County Council hereby directs that the proceeds of the sale of the real property described in Section 1 above, less the costs of the sale, shall be placed in the County's General Fund and specifically earmarked and only used for recreational trail purposes.

**Section 3. Effective Date**. This ordinance shall take effect upon the date of its adoption.
