### **UPDATE TO THE LAND DEVELOPMENT REGULATIONS**

Ms. Gucker stated the School District was good about attending the meetings and there were citizens in attendance from time to time. Many comments were received not only from the group that met on a regular basis, but comments were received about concerns Council members had and Planning Commissioner had. Ms. Gucker recognized Judy Wortkoetter and Hesha Gamble who took the lead in facilitating the meetings.

Hesha Gamble addressed the Committee members with a summary of the changes that were made to the Land Development Regulations. Hesha, Judy Wortkoetter and Eric Vinson answered various questions the Committee members had. After some discussions the following motion was made.
