GRANT APPLICATION:

DSS AFTERSCHOOL SNACK PROGRAM GRANT:

This is the DSS AfterSchool Snack Program Grant. This grant will be used by Parks, Recreation, and Tourism to provide snacks for the afterschool snack program. The amount of the grant is based on the cost of \$0.86 per snack. This grant does not require a County match.

Ruth Parris, Budget Coordinator and Lawanda Curry, Parks, Recreation, & Tourism were present to answer questions of the committee.

Councilor Norris moved to approve the DSS Afterschool Snack Program which will reimburse the County at a rate of \$0.86 per snack. The motion carried unanimously.

CLEAR SPRING FIRE AND RESCUE DISTRICT:

This is an ordinance for the issuance and sale of not exceeding \$4,500,000 in General Obligation Refunding and Improvement Bonds for the Clear Spring Fire and Rescue District. This will allow for the construction of a new headquarters building on its current site.

Chief Mull, Brad Love, Bond Counsel and Teressa Cawley, Financial Advisor were present to answer questions of the committee.

Councilor Kirven moved to approve the issuance of not exceeding \$4,500,000 in General Obligation Refunding and Improvement Bonds for the Clear Spring Fire and Rescue District. The motion carried unanimously.

COMMUNITY PROJECT APPLICATIONS:

GREENVILLE COUNTY PARKS, RECREATION & TOURISM - SLATER HALL INTERNET ACCESS:

This is a Community Project Application in the amount of \$1,745 for the Greenville County Parks, Recreation & Tourism. This funding will allow the IS Department to install conduit for the installation of new lines to increase internet access and service to participants in the Senior Program.
