This is a request from Greenville County Library for authorization from the Chairman of County Council and the County Administrator to sale property located at Hill Top Drive. Approval of request allows the Library to sell property which it and the County have no present or future interest.

LEASE AGREEMENTS:

SHARE BUILDING:

This is an ordinance to authorize the Chairman of County Council and the County Administrator to execute a lease of County owned property located at 1200 Pendleton Street with the South Carolina Children's Theatre.
