It is with pleasure that I submit to you for nominations as Code Enforcement Officers, George Ramos, Elisabeth Flint, Terry Fowler, Bill Roinestad, Robert Stewart and Austin Deming.

George Ramos is employed as a Code Enforcement Officer. George is certified as a Property Maintenance and Residential Building Inspector. He is continuing to achieve certification as Zoning Inspector. George has been employed by the county since October 9, 2017.

Elisabeth Flint is employed as an Inspector with the County. Elisabeth has achieved certification as a Residential Building Inspector. Elisabeth has been employed by the county since July 24, 2017.
