

A RESOLUTION

TO ENLARGE THE BOUNDARIES OF THE METROPOLITAN SEWER SUBDISTRICT TO INCLUDE THE PROPERTY IDENTIFIED AS TAX MAP NUMBERS 0585010100603; 0585010100604; AND 0585010100606 LOCATED AT THE INTERSECTION OF WEST GEORGIA ROAD AND SULLIVAN ROAD, AND TO PROVIDE FOR PUBLIC NOTICE THEREOF.

WHEREAS, pursuant to Section 6-11-410, et seq., of the Code of Laws of South Carolina, 1976, as amended (“S.C. Code”), the governing bodies of the several counties of the State are authorized to enlarge, diminish or consolidate any existing special purpose districts located within such counties; and Greenville County Council is the governing body of Greenville County, South Carolina; and

WHEREAS, the Metropolitan Sewer Subdistrict (“District”) was created by Act No. 687 of the 1969 Acts and Joint Resolutions of the General Assembly of the State of South Carolina, and as such is a special purpose district to which has been committed the function of constructing and maintaining sewage collector lateral lines within its boundaries within Greenville County; and

WHEREAS, a petition has been submitted to Greenville County Council by the owner of the real property identified as Tax Map Numbers 0585010100603; 0585010100604; and 0585010100606 located at the intersection of West Georgia Road and Sullivan Road, and shown on “Exhibit A” attached hereto and incorporated herein by reference, to have said property annexed into and made a part of the Metropolitan Sewer Subdistrict; and

WHEREAS, Metropolitan Sewer Subdistrict has consented to the annexation; and

WHEREAS, the Greenville County Council finds that the property described in “Exhibit A” is located wholly within the boundaries of Greenville County, South Carolina, but is not within any special purpose district or municipality which is empowered to construct and maintain sewage collector lateral lines, that annexing such property into the Metropolitan Sewer Subdistrict would extend the facilities for the construction and maintenance of sewage collector lateral lines within its boundaries within the boundaries of the District; and

WHEREAS, Greenville County Council finds that it is in the public interest that the boundaries of said District be enlarged so as to include the property described above and appearing on “Exhibit A”.

NOW, THEREFORE, BE IT RESOLVED by Greenville County Council that the boundaries of the Metropolitan Sewer Subdistrict are hereby enlarged to include the real property known as Tax Map Numbers 0585010100603; 0585010100604; and 0585010100606, further described on “Exhibit A”, and that pursuant to S.C. Code Ann. § 6-11-470 (Supp. 2001), the

Clerk of the County Council shall cause to be published in a newspaper of general circulation in Greenville County, once a week for two successive weeks the following information:

- (a) the results of this action of the Greenville County Council;
- (b) the fact that this Resolution does not authorize the issuance of additional bonds by the Metropolitan Sewer Subdistrict; and
- (c) the fact that there will be no new Commission or changes made in the personnel of the present Commission of the Metropolitan Sewer Subdistrict.
