Item (7) RESOLUTIONS

(a) Greenville County Master Lease

ACTION:

Councilor Taylor moved for adoption a resolution authorizing the Master Lease Agreement in the principal amount of not exceeding \$4,000,000 relating to the financing of equipment for public purposes; authorizing the execution and delivery of various documents; and other matters relating thereto.

Motion carried unanimously.

(b) Project Infinity / Inducement Resolution

ACTION:

Councilor Taylor moved for adoption a resolution authorizing the execution and delivery of an inducement agreement by and between Greenville County, South Carolina and Project Infinity, whereby, under certain conditions, Greenville County would execute a fee in lieu of tax agreement with respect to a project in the County whereby the project would be subject to payment of certain fees in lieu of taxes; and providing for related matter.

Motion carried unanimously.

Item (8) ORDINANCES – THIRD READING

(a) Zoning Ordinances

1. CZ-2018-10: Property of Votto Otto Boehme and Pamela Gayle Butler, located at 290 Rockcrest Drive, requesting rezoning from R-20 to R-20A.

ACTION: Councilor Ballard moved adoption of the ordinance at third reading.

Motion carried unanimously.

2. CZ-2018-23: Property of Lisa K. Plumbley, located at 3424 Brushy Creek Road, requesting rezoning from R-12 to C-2.

ACTION: Councilor Ballard moved adoption of the ordinance at third reading.

Motion carried unanimously.

3. CZ-2018-25, Property of Gabriel Builders Inc., located on White Horse Road, requesting rezoning from R-S to C-3 (front portion of parcel only).

ACTION: Councilor Ballard moved adoption of the ordinance at third reading.

(a) Greenville County Library System / FY2019 Budget Ordinance

Councilor Taylor moved for approval at second reading an ordinance to approve the appropriation of funds for the Greenville County Library System for the Fiscal Year beginning July1, 2018 and ending June 30, 2019; and to authorize the annual ad valorem property tax millage levy for library purposes.

(b) Project Poetry / Fee in Lieu of Tax Agreement

Councilor Taylor moved for approval at second reading an ordinance authorizing the execution and delivery of a fee in lieu of tax agreement by and between Greenville County, South Carolina and a company or companies known to the County at this time as Project Poetry with respect to certain economic development property in the County, whereby such property would be subject to certain payments in lieu of taxes: and other matters related thereto.

(c) Project Stryker / Fee in Lieu of Tax Agreement

ACTION:

Councilor Taylor moved for approval at second reading an ordinance authorizing the execution and delivery of a fee in lieu of tax agreement by and between Greenville County, South Carolina and a company or companies known to the County at this time as Project Stryker with respect to certain economic development property in the County, whereby such property would be subject to certain payments in lieu of taxes: and other matters related thereto.

Motion carried unanimously.

(d) Anderson – Greenville Multi County Industrial Business Park Agreement Amendment (2010 Park) / Project Stryker

ACTION:

Councilor Taylor moved for approval at second reading an ordinance to amend an agreement for the development of a joint county industrial and business park (2010 Park) of Anderson and Greenville Counties so as to enlarge the park.

Motion carried unanimously.

Item (15) REQUESTS AND MOTIONS BY COUNCIL MEMBERS

- Councilor Roberts stated a new set of defibrillators were being purchased through a grant from GHS. He added that he truly felt the additional defibrillators would reduce the chance of a loved one dying from cardiac arrest. He commended the leadership at the Sheriff's Department and County Staff who coordinated the grants and purchased the defibrillators.
- Councilor Seman stated SCTAC was pleased to announce Will Komar as the newest public relations intern. She added that Will was a rising senior at Clemson University, majoring in management and economics.

- Councilor Fant recognized the members of District 25 and Vision 25 who were in attendance and thanked them all for their continued hard work.
- Councilor Ballard invited everyone to attend a meet-and-greet in Piedmont on Saturday, June 9, at 2:00 p.m. He added that Piedmont was attempting to become the "New Travelers Rest." Mr. Ballard stated an investor had purchased one of the old mills and would be restoring it; there were other plans on the horizon and he was very excited to see efforts to revitalize the town.
- Councilor Payne stated he was very excited to see Greenville County poised to move forward in transportation innovations. He stated an agreement had been reached with the Federal Highway Administration to accept a \$4 million matched grant.
- Councilor Barnes recognized Chief Deputy Davenport, Major Taylor and all the members of the Greenville County Sheriff's Office who were in attendance. He thanked them all for their hard work.
- Vice-Chairman Meadows thanked Lt. Governor Kevin L. Bryant who visited Greenville County yesterday and presented \$500,000 for the Berea Community Center.
- Councilor Dill requested County Staff re-examine the situation with the feral cats to see if a better solution was available.
- Councilor Dill wished Happy Birthday to Councilor Ballard, Councilor Fant and Councilor Roberts.
