**1.) Descriptions of event, activity, function or project for which funding is requested:**

The Historic Slater Hall Rehabilitation project aims to update the facility to maximize community use, improve physical appearance, and enhance functionality for public safety purposes. Built in 1934, Slater Hall has served the Slater-Marietta community for 84 years and counting. Public safety standards have improved while building conditions have deteriorated, requiring Greenville County to address several structural and aesthetic enhancements. This project will continue these efforts to rehabilitate Historic Slater Hall, focusing on emergency exits, porch columns, and window louvers.

**2.) Proposed plan with detailed Goals and Objectives and proposed Performance Measures i.e. those mechanisms by which the success of the project in achieving its goal(s) can be measured:**

The project will address public safety concerns to keep Historic Slater Hall open and welcoming to community use. The goal is to complete several construction and rehabilitation upgrades to the aging building. The Objectives are:

Replace 2<sup>nd</sup> story window louvers

Reinforce front porch columns.

Replace 2<sup>nd</sup> story fire escape and emergency exit door.

These objectives will be measured by successful completion of construction and rehabilitation projects to satisfy local building codes, construction permitting, and community association leaders. The Slater Hall Citizen's Committee has requested these projects as priorities in recent community meetings and this grant funding will directly address their concerns.

Yes. Public safety improvements to the Historic Slater Hall building will sustain and improve programming at the site where current employees and community associations administer special events, meeting space, and recreational programs for children, seniors, and adults of the Slater-Marietta community.

Historic and cultural tourism are popular activities in South Carolina. Slater Hall is among several facilities managed as historic sites by Greenville County Parks, Recreation, & Tourism in the Upstate, including Poinsett Bridge, Campbell's Covered Bridge, and Pleasant Ridge Park. Rehabilitating the Historic Slater Hall building will help define the location as a historic destination and a renewed point of community pride.

- The grantee must prepare a report to SCPRT within 90 days after the event or project completion reporting the actual revenues and expenditures relating to the budget submitted as part of the application. The report must also contain the results of the proposed performance measures detailed in question #2. In addition, facility improvement projects must include before and after pictures.
- Failure to comply with the above will result in the grantee being deemed as non-compliant by SCPRT. As a result, the grantee will be barred from receiving any grant funds administered by SCPRT until the issue is remedied. SCPRT currently administers the Tourism Advertising Grant, Parks and Recreation Development fund, Land and Water Conservation fund, Recreational Trails Program, Undiscovered SC Enhancement Grants, and the SC Sports Tourism Advertising and Recruitment grant program.
