BOARDS & COMMISSIONS: ACCOMMODATIONS TAX ADVISORY COMMITTEE

GRANT APPLICATIONS:

BEST FRIENDS ANIMAL SOCIETY GRANT:

This is the Best Friends Animal Society Scholarship Grant in the amount of \$2,000. These grant funds will be used by Animal Care Services to send Animal Care employees to the Best Friends National Conference. This grant does not require a County match.

Ruth Parris, Budget Director and Shelley Simmons, Animal Care were present to answer questions of the committee.

PETCO FOUNDATION GRANT:

This is the Petco Foundation Grant in the amount of \$100,000. This grant will be used by Animal Care Services for the purpose of life-saving, such as reducing the number of animal entering our shelter and/or increasing the live outcomes of animals that are in the shelter. This grant does not require a County match.

Councilor Norris moved to approve the Petco Foundation Grant Grant in the amount of \$100,000. The motion carried unanimously.

ATLANTIC HOUSING FOUNDATION - REVENUE BONDS:

This is a resolution regarding the issuance by the Public Finance Authority of its Multi-Family Housing Revenue Bonds in an amount not exceed \$22,000,000 for the purpose of defraying the costs of acquiring certain Multi-Family affordable housing facilities.

Councilor Cates moved to approve the Community Project Application for Donaldson Center Fire Department in the amount of \$3,800. The motion carried unanimously.
