## **GRANT APPLICATIONS:**

### FY2018 LEMPG:

The grant has an in-kind County match of \$253,883 and it will come from budgeted salaries and benefits in the Emergency Management Division (Sheriff's Office).

## FY2018 VOCA GRANT:
