Item (3) Approval of the Minutes of the Regular Meeting of PWI Committee on March 20, 2018.

Item (4) Commissioning of Code Enforcement Officer

Teresa Barber, Director of Code Enforcement addressed the Committee members with a request to forward to full Council the Commissioning of James Brian Bishop as Code Enforcement Officer. Mr. Bishop has been with Greenville County since October 2014. He is a certified flood Plain Manager and Professional Engineer. He received his Civil Engineering Degree from Clemson University. She stated Brian has shown to be a valued employee during his tenure and is eligible for his Commissioning as Code Enforcement Officer.

Ms. Gucker added she and Brian have worked together and he does an excellent job. She stated she and he would present to the Committee at some time in the future the presentation which they have given on floodplain.

Item (5) <u>Waterline Application – Roberts Circle</u>

Paula Gucker addressed the Committee members with a grant request from Steve and Ann Larson for the installation of 280 feet of waterline along Roberts Circle to serve the property. She stated they have met all the requirements and have provided their portion of the funding in the amount of \$4,200.00. Ms. Gucker provided the Committee with the balance in the waterline grant account after this project as being \$154,417.78.

MOTION: By Mr. Ballard to approve and forward to full County Council the waterline grant application for Roberts Circle. The motion carried unanimously by voice vote.
