Museum Commission – 2 Vacancies and 3 applicants

Item (5) Surplus Right-of-Way Acquisition adjacent to 312 Traynham Boulevard (L0498)

Hesha Gamble, County Engineer addressed the Committee with a request from Mr. Elliot Poole who would like to acquire 0.01 acres of unimproved right-of-way adjacent to his property. She stated Greenville County would like to relinquish any interest the division may have in the surplus right-of-way which will allow the surplus property to be combined with that map number 0468000400300.

Item (6) Revisions to the Greenville County Flood Damage Prevention Ordinance

Brian Bishop, Floodplain Administrator addressed the Committee with revisions to the Flood Damage Prevention Ordinance. He stated the revisions were additions which were mandated by FEMA AND THE Department of Natural Resources (DNR).

Mr. Bishop answered questions from the Committee and clarified some of the revisions.

Item (7) Waterline Grant – 204 Georges Hideaway

Paula Gucker, Assistant County Administrator addressed the Committee with a Council Grant Assistance for 204 Georges Hideaway. She stated the Finnell's are requesting waterline installation in the amount of \$9300.00 and they have paid their portion which is \$4650.00. Ms. Gucker noted their well was going dry and they have provided a certified letter from Billy's Plumbing. Ms. Gucker stated the balance in the Grant Account after this grant would be \$104,287.
