

These three areas have been designated as some of Greenville County's higher crime areas. Students who participate in quality summer programs, including learning curriculum for gang intervention and character development, are less apt to get involved in unproductive behaviors in the summer i.e. less vandalism, less crime, and less loitering of students in undesirable areas. Students will also continue to learn throughout the summer months, which will help retain information learned from the school year, keeping them on a path of success to graduate high school and become productive citizens of Greenville County.

Funds will be used to register students and offset the costs to operate the camp due to the lower economic levels in these areas.**
