# GREENVILLE COUNTY ART MUSEUM - GENERAL OBLIGATION BONDS AND MILLAGE INCREASE:

Greenville County Museum of Art is requesting a 0.3 mill increase in its tax rate consisting of 0.2 mill which represents the consumer price index and population growth lookback as allowed pursuant to S.C. Code § 6-1-320(A), and 0.1 mill for the maintenance of a reserve account pursuant to S.C. Code § 6-1-320(D). The Museum also requests approval of its capital improvement program and the issuance of GO Bonds in an amount not to exceed \$3,000,000.

Brad Campbell, Chair, Tom Styron, Executive Director, Amelia Stephenson, Board, Teressa Cawley, Southern Municipal Advisors and Brad Love, Haynsworth Sinkler Boyd were present to answer questions of the committee.

Councilor Cates entered the meeting at 5:23.

Councilor Seman moved to approve an ordinance to provide for the issuance and sale of not exceeding \$3,000,000 in General Obligation Bonds for the Greenville County Art Museum and a resolution authorizing a 0.3 mill increase. The motion carried unanimously.

# DREXEL TERRACE SPECIAL TAX DISTRICT - STREET LIGHTING:

This is an ordinance to create the Drexel Terrace Special Tax District; to define the boundaries of the district and the purpose for which it is created; to establish the district as an Administrative Division of Greenville County; and to impose an annual fee of not more than \$45.00 on all real property located within the district.

Kim Wunder, Assistant County Attorney was present to answer questions of the committee.

Councilor Meadows moved to approve the ordinance to create the Drexel Terrace Special Tax District; to define the boundaries of the district and the purpose for which it is created; to establish the district as an Administrative Division of Greenville County; and to impose an annual fee of not more than \$45.00 on all real property located within the district. # TRANSFER OF 4.2 ACRE PARCEL ON HILLTOP DRIVE IN TRAVELERS REST:

Councilor Meadows moved to approve an ordinance to authorize the transfer and conveyance of 4.2 acres of real property located on Hilltop Drive in the City of Travelers Rest owned by Greenville County for the exclusive use and benefit of the Greenville County Library System.
