BOARDS & COMMISSIONS – ACCOMMODATIONS TAX ADVISORY COMMITTEE:

There are five vacancies on the Accommodations Tax Advisory Committee. Applications were received from Penny Cooper, Victoria Fernandez and Joyce McCarrell.

Councilor Meadows moved to nominate and forward to the Committee of the Whole the following applicants: Penny Cooper, Victoria Fernandez and Joyce McCarrell to fill the three vacancies on the Accommodations Tax Advisory Committee. The motion carried unanimously.

WIOA GRANT FOR SECTOR PARTNERSHIPS:

This is the WIOA Grant in the amount of \$25,000. The grant funding will be used to continue with regional industry-led sector partnerships per South Carolina's Talent Pipeline Initiative. The goal of industry-led sector partnerships is to cultivate the development of a skilled workforce and a responsive workforce system. Grant funds will be used to help pay for the salaries of the Link Upstate business services representatives who are responsible for facilitating the public and private industry-led sector partnerships across 14 counties in the Link Upstate Region. The grant does not require a local match.

Dean Jones, Workforce Development was present to discuss the request and answer questions of the committee.

Councilor Norris moved to approve the WIOA Grant in the amount of \$25,000. The motion carried unanimously.

SOUTH CAROLINA CHILDREN'S THEATRE – FUNDING REQUEST:

Council provided H-Tax funding to the South Carolina Children's in the amount of \$250,000 on March 7, 2017. The S.C. Children's Theatre is requesting an additional \$250,000 in H-Tax funding.

Debbie Bell, Executive Director and Mary Adams, Development Director were present to answer questions of the committee.

Councilor Meadows moved to approve the funding request for \$250,000 for the S.C. Children's Theatre. The motion carried unanimously.
