GRANT APLICATIONS:

SC PARKS AND RECREATION – HISTORIC SLATER HALL REHABILITATION:

This is the SC Parks & Recreation – Historic Slater Hall Rehabilitation Grant in the amount of \$40,000. These grant funds would be used to continue the update of the Historic Slater Hall to maximize community use and improve physical appearance, and enhance functionality for special events. In 2018, Parks and Recreation received a grant to address safety issues for Slater Hall. This current grant request will address exterior aesthetics, focusing on windows and porch columns. This grant does not require a County match.

John Hansley, Deputy County Administrator was present to answer questions of the committee.

Councilor Kirven moved to approve the SC Parks & Recreation & Historic Slater Hall Rehabilitation Grant in the amount of \$40,000. The motion carried unanimously.

SC BAR FOUNDATION BANK OF AMERICA GRANT:

This is the SC Bar Foundation Bank of America Grant in the amount of \$75,000. The grant funds will be used by the Human Relations Commission to launch a new Mortgage Assistance Program in Greenville county. The grant does not require a local match.
