RECITALS

WHEREAS, the County, acting by and through its County Council (the "Council"), pursuant to the provisions of the Code of Laws of South Carolina 1976, as amended (the "Code"), particularly Title 12, Chapter 44 of the Code (the "Negotiated FILOT Act"); Title 4, Chapter 1 of the Code (the "Multi-County Park Act") or, as to Section 4-1-175 thereof, the "Special Source Act") (collectively, the "Act") and Ordinance No. 5121 duly enacted by Council on September 3, 2019 (the "FILOT Ordinance"), entered into a Fee-in-Lieu-of-Tax Agreement, dated as of September 3, 2019 (the "Fee Agreement"), pursuant to which the Assignor agreed to make, and the County agreed to accept, negotiated fee in lieu of tax payments ("FILOT") with respect to certain eligible property ("FILOT Property") comprising a multi-tenant commercial/industrial facility located within the County (the "Project"); and

WHEREAS, the Assignor desires to assign all of its interests in the Fee Agreement and the FILOT Ordinance to the Assignee, as part of the Assignee's acquisition of the Assignor's FILOT Property (the "Assigned FILOT Property"); and

WHEREAS, the County has considered the Assignors' request to assign all of their interests and, by Resolution adopted by the County on ________, 2020, the County approved and consented to the assignment to the Assignee by the Assignor of all of the Assignor's right, title and interest in the FILOT Ordinance, the Fee Agreement and the Assigned FILOT Property.

NOW, THEREFORE, FOR VALUE RECEIVED, it is agreed as follows:

- 1. The Assignor hereby assigns, transfers and delivers to the Assignee all of the Assignor's right, title and interest in and to the FILOT Ordinance, the Fee Agreement and the Assigned FILOT Property, and all matters related thereto, on and after the date first written above (the "Effective Date"), including all rights, duties, and obligations conferred by the FILOT Ordinance and the Fee Agreement upon the Assignors. On and after the Effective Date, Assignors shall be fully released and discharged from any and all of Assignors' obligations under the FILOT Ordinance and Fee Agreement except as those obligations arise directly from Assignors' actions or inactions which occurred prior to the Effective Date.
- 2. The Assignee hereby accepts the assignment of all of the Assignor's right, title and interest in and to FILOT Ordinance, the Fee Agreement and the Assigned FILOT Property, and

agrees to be bound by and perform, observe, and otherwise comply with all of the obligations, covenants and undertakings of the Assignor with respect to the FILOT Ordinance, the Fee Agreement and the Assigned FILOT Property from and after the Effective Date.
