AN ORDINANCE

TO AUTHORIZE THE TRANSFER OF COUNTY OWNED PROPERTY LOCATED 48 RIDGEWAY DRIVE, THE FORMER WOODFIELD COMMUNITY CENTER SITE, TO THE GREENVILLE COUNTY REDEVELOPMENT AUTHORITY, AND TO AUTHORIZE THE EXECUTION OF A QUIT-CLAIM DEED RELATED THERETO.

WHEREAS, Greenville County Council supports the mission of the Greenville County Redevelopment Authority (GCRA) to improve and revitalize homes and communities in Greenville County; and

WHEREAS, Greenville County Council desires to donate and transfer the property located at 48 Ridgeway Drive, the former Woodfield Community Center, to the GCRA in furtherance of the mission of providing affordable housing, and building safe, accessible neighborhoods.

NOW, THEREFORE, BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

Section 1. Authorize Transfer. The Chairman of Greenville County Council and the County Administrator are hereby authorized to execute, on behalf of the County of Greenville, a Quit Claim deed substantially in the form attached hereto as *Exhibit A*, between the County of Greenville, as Grantor, and Greenville County Redevelopment Authority, as Grantee, for the purpose of conveying the County's interest in the real property located at 48 Ridgeway Drive, Greenville, South Carolina. The Chairman of County Council and the County Administrator are further authorized to execute any other appropriate documents and agreements necessary for the transfer of the property.

Section 2. Effective Date. This ordinance shall take effect upon the date of its adoption.
