

A RESOLUTION

TO PROVIDE FOR THE MILLAGE RATE TO BE LEVIED BY THE SLATER-MARIETTA FIRE DISTRICT.

WHEREAS, the Slater-Marietta Fire District is a special purpose district located wholly within the County of Greenville; and

WHEREAS, the Board of Commissioners for the Slater-Marietta Fire District, is authorized by law to annually levy, for operations and maintenance, ad valorem property tax millage and by resolution has approved and requested an increase of its present millage rate; and

WHEREAS, according to the provisions contained in S.C. Code §§ 6-11-271 and 6-11-275, as amended, special purpose districts totally located within a county, which were in existence prior to March 7, 1973, and which have the statutory authority to annually levy taxes for operations and maintenance, are authorized to increase their respective millage limitations upon the written approval of the governing body of the county in which they are located; and

WHEREAS, by separate resolution and ordinance, Slater-Marietta Fire District has petitioned County Council to authorize the Board of Commissioners for the Slater-Marietta Fire District to issue general obligation bonds not exceeding \$3 million, subject to favorable results of a referendum.

NOW, THEREFORE, BE IT RESOLVED that Greenville County Council approves an ad valorem property tax increase of one and one tenths (1.1) mills bringing the total millage for operations and maintenance to twenty-six and one tenths (26.1) mills for the Slater-Marietta Fire District, which consists of operating millage allowable (CPI and population growth) for FY2021-2022 pursuant to S.C. Code § 6-1-320(A)(1) and operating millage allowed but not imposed for the preceding property tax year pursuant to S.C. Code § 6-1-320(A)(2). Additionally, County Council approves continuance of a levy of nine and two tenths (9.2) mills for the maintenance of a reserve account pursuant to S.C. Code § 6-1-320(D).

BE IT FURTHER RESOLVED that the millage increase authorized by this Resolution is effectuated pursuant to S. C. Code §§ 6-11-271 or 6-11-275, as amended.

BE IT FURTHER RESOLVED, the ad valorem property tax millage increase set forth herein is based on 2020-2021 millage rates and is subject to reassessment year calculations pursuant to S.C. Code § 12-37-251(E) by the County Auditor. The Auditor and Tax Collector of Greenville County are hereby directed to levy and collect the millage rates authorized by this Ordinance.
