Re: EMS - GIA Funds SFY2022

Dear Mr. Kernell:

The South Carolina Department of Health and Environmental Control ("DHEC") distributes state appropriated EMS funds in accordance with Section 34.8 of the Part IB Provisos of the 2021-2022 Appropriations Act. The funds must be utilized as outlined in this document and for the purpose of improving and upgrading the Emergency Medical Services system throughout the state. The funds are allocated in accordance with the following methodology or formula: 50% of the funds appropriated will be allocated equally among the 46 counties in SC and the remaining 50% will be allocated based on the proportion of the population in each county. Greenville County's allocation for Fiscal Year 2021-2022 is determined to be \$32,884.21.

Proviso 117.21 in the Miscellaneous Provisions section of the Act requires organizations receiving contributions from DHEC in the Appropriations Act to provide the following documentation by November 1st of the year that the funds are to be received:

- 1. An accounting of how the state funds will be spent;
- 2. Goals to be accomplished;
- 3. Proposed measures to evaluate success in implementing and meeting the goals;
- 4. A copy of your adopted budget for the current year; and
- 5. A copy of your organization's most recent operating financial statement.

Disbursement of these funds will take place once this information has been received, reviewed, and processed by DHEC. No funds shall be disbursed to organizations or purposes which practice discrimination against persons by virtue of race, creed, color, or national origin.

Proviso 117.21 further requires for accountability purposes that an organization receiving funds from DHEC submit a report to the Department by June 30th that includes the following information:

1. An accounting of how the funds were spent; and

2. Outcome measures used to determine the success of the stated goals.

In addition to these requirements, Proviso 34.8 requires local matching funds to be provided by the recipients of the allocations. In order to meet these requirements, we will need the following:

1. Documentation that the receiving party meets the 5.5% matching amount and a description of the local matching funds.

Please remember to timely submit such information to DHEC should your organization receive EMS funds.

Code Section 11-9-110 requires that an organization receiving funds submit to the Executive Budget Office and the Revenue and Fiscal Affairs Office by the end of the fiscal year (June 30, 2022) a detailed statement explaining the nature and function of its organization as well as a detailed statement explaining the use that was made of the funds. Funds will not be distributed to an organization until it agrees in writing to allow the State Auditor to audit or cause to be audited the Funds.

Greenville County EMS is excited to receive the Grant in Aid funds for the 2022 fiscal year. The goal of these funds is to greatly improve our system by providing further training equipment and certificate level courses to our employees. Greenville County EMS would like to offer additional training experiences for our MedCom employees and our Risk and Safety Manager. MedCom currently dispatches EMS units for the entire county, as well as sixteen area fire departments. We are proud to state that our MedCom center has earned accreditation as an Emergency Medical Dispatch Center of Excellence. The expanded training abilities will ensure MedCom continues to provide exceptional service to Greenville County citizens and visitors. Greenville County EMS would also like to increase the safety measures we already have in place with further training for our Risk and Safety Manager and by increasing the 1. Greenville County EMS will purchase 10 vouchers and enroll number of portable radios in the field. employees into the EMD certification course. Upon completion of the course, each employee will become EMD nationally certified. This course will allow them to improve the quality of service they provide to each caller, identify chief complaints, assign needed resources, and provide crusial pre-arrival instructions. 2. Similar to the EMD certification, Greenville County EMS will purchase 45 vouchers and enroll employees into an Emergency Fire Dispatch (EFD) certification course. Upon completion of the course, each employee will become EFD nationally certified. The EFD certification course will allow MedCom employees to further their knowledge in fire dispatch by studying fire operations, protocol instructions, and quality imporvement practices. 3. Once all MedCom employees are certified in EMD and EFD, Greenville County EMS will purchase vouchers and enroll them into the ProQA EMD (41 employees) certification course. This course is an extension of EMD. The ProQA course incorporates the adaptive software and technology systems with the practices each employee learned during the EMD certification course. ProQa certifications will assist MedCom in tracking measureable performance goals, allow each call to be rviewed in detail, and increase compliance. ProQA will also ensure that MedCom continues to 4. An ED-Q certification course meet universal best practice standards and reduce liability. will assist Greenville County EMS in producing reliable, credible, and consistent quality improvement. Five employees will be enrolled into the course and will become ED-Q certified. This course will allow the employees to further understand the quality improvement process, set standards, evaluate performance, and analyze data. 5. Greenville County EMS will enroll the Communications Manager in the Emergency Medical Dispatch Instructor course and purchase the EMD Instructor Toolkit. This course will allow MedCom to have an in house instructor and enhance the experience of EMD certificaiton for our employees. Once certified, the instructor will be able to offer EMD certification courses when new employees are on boarded. It will also give Greenville County EMS the ability to serve our greater community by offering EMD training to other dispatching agencies. 6. Greenville County EMS will purchase 3 protocol tablets to replace the EMD card system that is being phased out of production. Not only will these tablets replace an outdated card system, they will also be used to enhance the training experience during the EMD and EFD certification courses. 7. Greenville County EMS will purchase 2 laptops, 7 webcams, and 7 headset adapters to facilitate virtual certification classes and ongoing training for each employee. The laptops will allow trainees the ability to mirror the input of calls while sitting at the console with their trainer. The webcams and headset adapters will allow employees to connect to our current training computers for virtual learning. 8. The Safety and Risk Manager will be enrolled into the Advanced Designated Infection Control Officer Traning Course. He is currently the designated officer responsible for managing exposures for our department and is certified at the Designated Infection Control Officer level. This training would further expand his abilities by giving our department the ability to plan for and create processes that will mitigate risks for our employees and help create a safer work eniroment. Futhermore, it will also improve patient and provider safety.

Goals: 1. To have all MedCom employees certified in Emergency Medical Dispatch and Emergency Fire Dispatch to ensure compliance with the International Academy of Emergency Dispatch. 2. Provide additional training and familiarity with the ProQA software used by Greenville County telecommunicators to ensure compliance and efficiency when allocating resources and providing pre-arrival instructions to persons with medical emergencies. 3. Provide standardization and certifications for proper coding of emergency calls pertaining to Fire Department response. 4. Increase the Quality Assurance and Compliance component of Greenville County EMS to provide additional training and feedback to employees. 5. To diminish employee risk and provide a safer environment for our patients and employees Measurements: Greenville County EMS will measure the success of this request by performing ongoing quality assurance checks as well as setting target numbers of telecommunicators to be trained within the department. We will also measure the efficacy of the Advanced Designated Infection Control Officer by tracking the number of trainings given to field providers. Greenville County EMS will continue to track our exposures and adjust our training to minimize risk to employees and patients.
