I have made a special effort to volunteer in the Greenville Community in different ways and for different organizations.

Describe your understanding of the position for which you are applying.

It is my understanding that I will be one of five Commissioners that are appointed to serve on the Greater Greenville Sanitation Commission. The members of the Commission are responsible to review policy and procedures to ensure all requirements are met and services provided. Working with staff to review financial, maintenance, operational plans and programs to ensure compliance with all legal and budgetary requirements. I understand that the Commission Chairman will assign each Commissioner an area of the operations to work with staff and present plans and concerns at each meeting.

It is my understanding that at a minimum, I will be required to attend scheduled meetings once each month and special meetings as called. I will be assigned by the Commission Chairman to serve on a sub-committee relating to a service area in the organization that I have expertise in. This will require additional time to meet with staff and other advisors. The reports and recommendations will be presented to the full Commission at regular meetings.

As a Commissioner, I will provide leadership to staff ensuring that the customers are served to the highest quality standard. The services will be provided in an efficient and cost effective manner. The Operations will stay in full compliance with all Federal, State, and Local laws, rules, and regulations. All employees will be trained in their area of operations and safety and health will be a major concern.

What specific skills do you believe you could contribute as a member of this board or commission?

My career has spanned decades of work experience in various management positions.

Management- I have fleet safety experience acquired while working as Safety Manager with AT&T (BellSouth). I implemented vehicle safety inspection programs, employee safety education, and supervisor field visits to ensure compliance with safety policy. Random driver's license inspections to make sure all drivers had valid licenses. These safety policies reduced accidents and lost time injuries.

Logistics- I worked with budgets such as tool, expense, and overtime. An example, I kept tool records of all tools I ordered and I completed annual tool inspections to ensure all tools and equipment was accounted for and in good working order. This procedure reduced tool expenditures.

Commercial Driving- I have spent many years managing and providing driving experience and training employees so that they could obtain a Commercial Driver's License.

Commissioner Experience- I was appointed as a commissioner for GGSC in December 2017.

The following have been accomplished from that time to present:

- Sold 120 acres on Old Piedmont Highway to Southeastern Freight Lines for \$3.9 Million
 - a. Eliminated \$270k per year of debt service
- Bought 152 acres on Highway 124 for new campus for just over \$2 million
 a. No debt carried on the property
- 3. Bought new yard waste collection equipment that was starting to become cost Prohibitive to run because equipment replacement had been delayed
- 4. Transitioned from bi-weekly to weekly collection of yard waste and recycling
- 5. In the process of migrating from rear loaders to automated side loaders to control Cost and turnover of collector positions that are becoming difficult to fill
- 6. Increased employee compensation by more that 40% in order to attract and retain employees
- 7. The only debt currently have is 2 equipment leases: one will be extinguished in FY 2023 and the other in FY 2024. Total owed on both is approximately \$600K
