Lawton, Jr. of Greenville in the State of South Carolina, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said T. O. Lawton, Jr. all that certain lot or parcel of land, situate, lying and being in the County of Greenville and State of South Carolina in what is known as "Park Place," near the City of Greenville, a revised Plat of which is of record in the Register of Mesne Conveyance Office for the County of Greenville in the State of South Carolina in Plat Book A at page 119, said lot being Number nine on said revised Plat in Block C and a part of the tract of land which was sold and conveyed to J. W. Cagle, T. Q. Donaldson and William Wilkins by Alexander Stewart and Jacob H. Susong, by deed bearing date 21st March, 1890, and recorded in Book VV, at Page 651, in R. M.
