E.A. Hudson and E.E. Hudson, of Greenville County in the State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

E.A. Hudson for and during the term of his natural life, and then to the said E.E. Hudson, All that piece, parcel or tract of land lying and being in Paris Mountain Township, Greenville County South Carolina, being a portion of the Estate of Mrs. A.A. Hudson, deceased and having the following metes and bounds to wit: Beginning at a pine 3XNM corner A. L. and P.E. Hudson's land and running; thence N. 74-3/4 W. 2.35 ch. to a stone; thence N. 21-3/4 W. 5.32 ch. to a stone; thence S. 41-1/2 W. 7.25 ch. to a stone; thence N. 83-1/2 W. 3.35 ch. to a poplar on branch; thence with branch in a N.W. direction 25.00 to a creek; thence with Creek in a N.E. direction 21.10 ch. to a branch A.L.
