(the receipt whereof is hereby

acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J.W. Crane, All that piece, parcel or tract of land situate, lying and being in the State, and

County aforesaid on Waters of Beaverdam Creek in Oneal Township and has the following metes and bounds, to wit:

Beginning at an Ash; thence N. 42 E. 13.68 chs. to Beaverdam Creek; thence up said Creek as a line 19.50 ch. to a stake in Creek; thence S. 70 W. 6.28 ch. to wild-cherry; thence S. 40-1/2 W. 4.84 ch. to a stone; thence S. 82 W. 2.80 ch. to a stone; thence N. 58-1/2 W. 8.02 ch. to an iron pin; thence S. 31-3/4 W. 7.10 ch. to a Pine-knot; thence S. 55-3/4 E. 30.58 ch. to the beginning corner, containing Forty-two (42) acres, more or less, adjoining lands of John Lynn, J.M.
