KNOW ALL MEN BY THESE PRESENTS, That I, Susan Harrison of Greenville County

in the State aforesaid

in consideration of the sum of Two hundred and no Dollars, to me in hand paid at and before the sealing of these presents by

Julia Chappell (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Julia Chappell all that certain piece, parcel or lot of land situated, lying and being in

sixth ward of the City of Greenville, County and State aforesaid, being a part of lot No. 6 Block 2, of a sub-division of lands of Hannah J. Cox, et al, situated on C. & G. RR and being further described as follows:

Beginning at a stake on West side of Glenn Street 118 feet from corner of St. John and Glenn Streets and running; thence N. 78 W. 100 ft. to a stake on line of lot No. 6; thence S. 12 W. 42 feet to corner of lots 5, 6, 7, 8; thence S. 78 W. 100 feet to a stake in line of Glenn Street; thence N. 12 E. 42 feet to beginning point, the same being a part of lot conveyed to me by the said Hannah J. Cox et-al, Jany. 26th, 1894 and recorded in R.M.C. office for Greenville County, S.C. in Book D. at page 204.

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
