in the State aforesaid for & in consideration of the sum of Five Dollars, to me in hand paid at and before the sealing of these presents by

R.D. Jones

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said R.D. Jones, all that lot or parcel of land situate in the Town of Simpsonville; County and State aforesaid and contains 20 one hundredths acres, more or less and hath the following metes and bounde to wit, Bounded by myself and D.R. Jones: Commencing at a stone running; thence S. 18 E. 76 to a stone; thence N. 85-1/2 W. 3.26 to a stone; thence N. 82 E. 3.04 to beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said R.D. Jones, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said R.D. Jones, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
