KNOW ALL MEN BY THESE PRESENTS, That: I, W.L. Gassaway

in the State aforesaid
in consideration of the sum of Eleven thousand no/100 Dollars,
to me in hand paid at and before the sealing of these presents by

J.W. Jervey and F. Jordan (the receipt whereof is hereby
acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
J.W. Jervey and F. Jordan, their heirs and assigns forever, all that piece, parcel or lot
of land situate in the City of Greenville, County and State aforesaid, on the South side
of Main Street and having the following metes and bounds:

Beginning at iron pipe on the West corner of the Geo. Brownlee lot, deed dated April 1st,
1910; thence with Western line of the Brownlee lot South 120 feet to an iron pipe
at a proposed side track; thence West 100 feet with said proposed side track and iron pipe
thence North 120 feet to Main Street parallel with the Brownlee line; thence East 100 feet
to the beginning corner, being a part of the B.E. Geer and B.H. Owen lots.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
J.W. Jervey and F. Jordan, their heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and
forever defend all and singular the said premises unto the said J.W. Jervey and F. Jordan, --

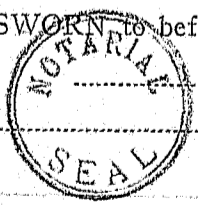
heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to
